County of Lincoln, Parts of Lindsey (Glanford Brigg), Definitive Map and Statement

"Definitive Map Modification (Public Bridleway 196, Bottesford) Order 2013(1)"

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln, Parts of Lindsey (Glanford Brigg), Definitive Map and Statement require modification in consequence of the occurrence of events specified in section 53(3)(a)(ii) – namely, a highway shown or required to be shown in the map and statement as a highway of a particular description has ceased to be a highway of that description – and section 53(3)(a)(iii) – namely, a new right of way has been created over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path or a restricted byway – of the Act.

North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 16 December 2013.
2. The County of Lincoln, Parts of Lindsey (Glanford Brigg), Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the "Definitive Map Modification (Public Bridleway 196, Bottesford) Order 2013(1)".

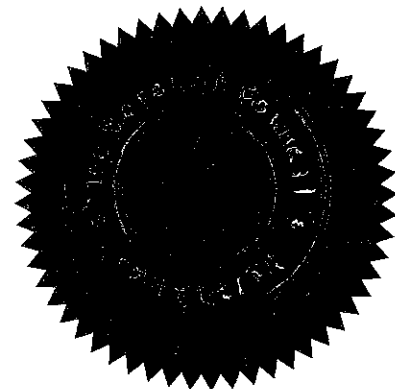

PART I

Modification of Definitive Map

Description of path or way to be upgraded

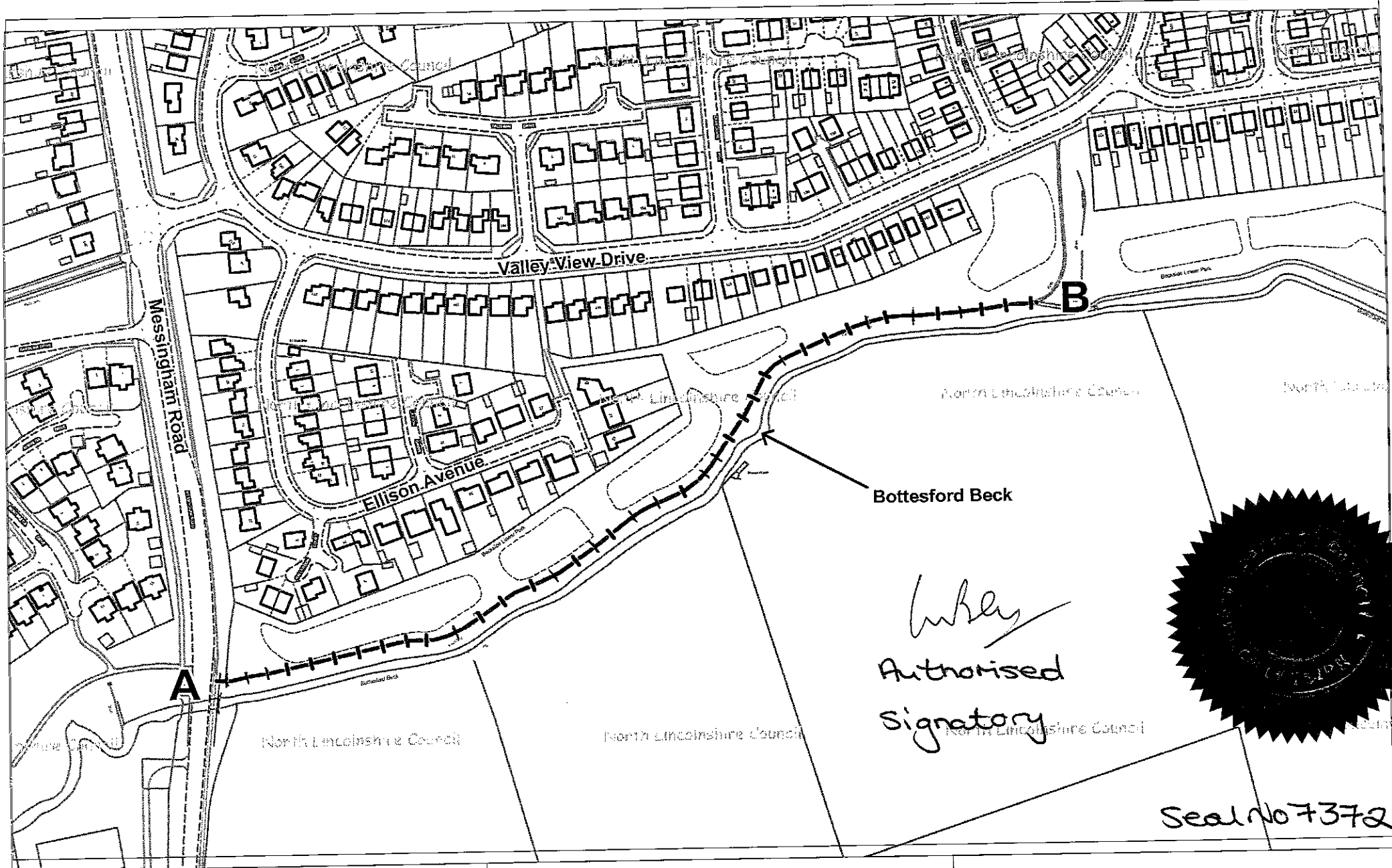
A – B, as indicated on the map: A 460-metre-long footpath commencing on Messingham Road at grid reference SE89140635 and proceeding in a generally east-north-easterly direction parallel to the northern bank of Bottesford Beck to a point 90 metres due south of 2 Worcester Close at grid reference SE89540653 is upgraded to bridleway.

PART II

Modification of Definitive Statement

Variation of particulars of path or way

A 460-metre-long bridleway with a width of three metres throughout commencing on Messingham Road at grid reference SE89140635 and proceeding in a generally east-north-easterly direction parallel to the northern bank of Bottesford Beck to a point 90 metres due south of 2 Worcester Close at grid reference SE89540653.
