This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement for the County of Lincoln – Parts of Lindsey (Glandford Brigg) require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i), namely, the coming into operation of any enactment or instrument or any other event whereby, a highway shown or required to be shown on the map and statement has been authorised to be stopped up, diverted, widened or extended, of the Act.

The authority have consulted with every local authority whose area includes the land to which the order relates. The North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 22<sup>nd</sup> June 2000.
2. The Definitive Map and Statement for the County of Lincoln – Parts of Lindsey shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is made and may be cited as the Public Footpath No. 109 Ulceby Definitive Map Modification Order 2000.

**SCHEDULE**

**Part I**

**Modification of County of Lincoln – Parts of Lindsey (Glandford Brigg)  
Definitive Map**

**Description of path or way to be deleted**

Public Footpath 109 in the Parish of Ulceby within the District and County of North Lincolnshire having a length of approximately 250 metres, commencing at point A on the map contained in this Order and proceeding in a generally southerly direction as a cross field path to point D on the map contained within this Order.

Description of path or way to be added

A footpath commencing at point A on the map contained within this Order proceeding in a south-westerly direction for 180 metres along the northern edge of a field to point B, continuing in a south-easterly direction for 125 metres along the western edge of the same field to point C; changing to a generally southerly direction for 42 metres to point D on the map contained in this Order.

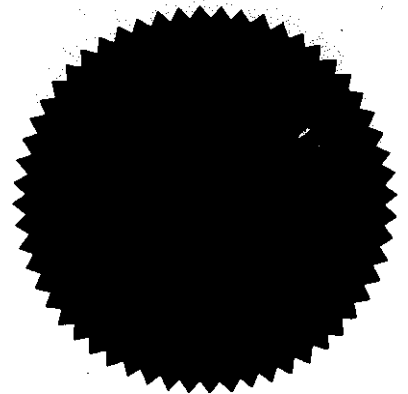

Variation of particulars of path or way

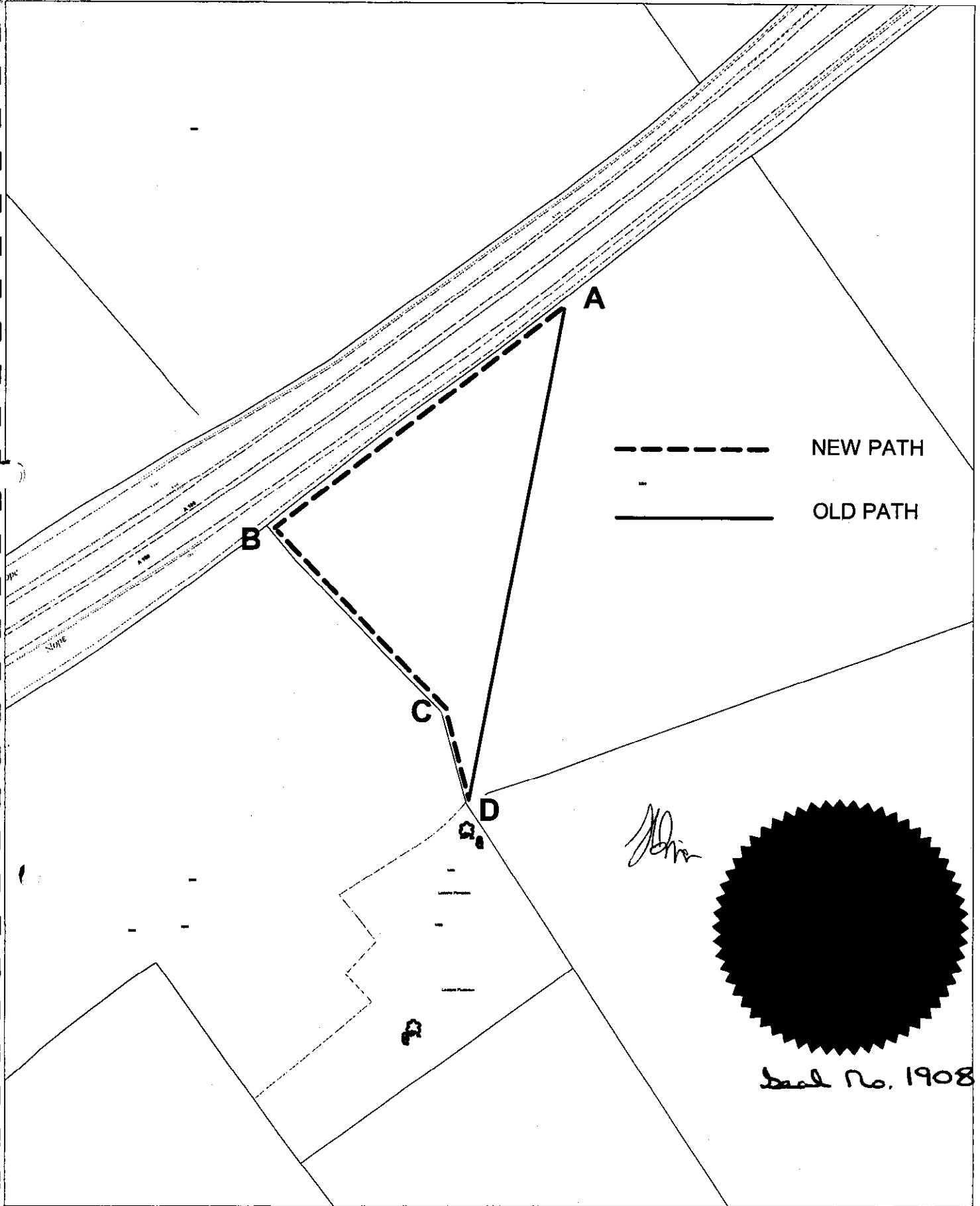
The footpath commences at OS grid reference TA10191330 and proceeds in a south-westerly direction as a field edge path for 180 metres to OS grid reference TA10051319; changing to a generally south-easterly direction and continuing as a field edge path for 125 metres to OS grid reference TA 10141310, continuing in a generally southerly direction for 42 metres to OS grid reference TA 10151305.

Width: A minimum of 1.5 metres
