**Footpath No. 9 Whitton  
Public Path Modification Order 2000**

This Order is made by North Lincolnshire Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("The Act") because it appears to that Authority that the Definitive Map and Statement for the County of Lincoln – Parts of Lindsey require modification in consequence of the occurrence of an event specified in Section 53(3)(a)(i), namely, a highway shown or required to be shown on the map and statement has been authorised to be diverted in accordance with the provisions of the Act.

The authority have consulted with every local authority whose area includes the land to which the order relates. The North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 13 January 2000.
2. The Definitive Map and Statement for the County of Lincoln – Parts of Lindsey shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to this order.
3. This order shall take effect on the date it is confirmed and may be cited as the No.9 Whitton Public Path Modification order 2000.

**SCHEDULE**

**PART I**

**Modification of County of Lincoln – Parts of Lindsey Map  
Description of path or way to be deleted**

Public Footpath No. 9 in the Parish of Whitton within the District and County of North Lincolnshire, having a length of approximately 500 metres, commencing at point 'A' on the map contained in this order and proceeding in an east-north-easterly direction across an arable field to point 'C' on the map.

**Description of path or way to be added**

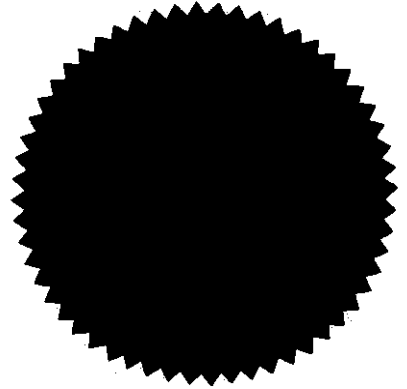
A footpath running from point 'B' on the map contained in this order in a south-easterly direction for 300 metres to point 'C' on the map contained in this order.

PART II

**Modification of County of Lincoln – Part of Lindsey Statement  
Variation of particulars of path or way**

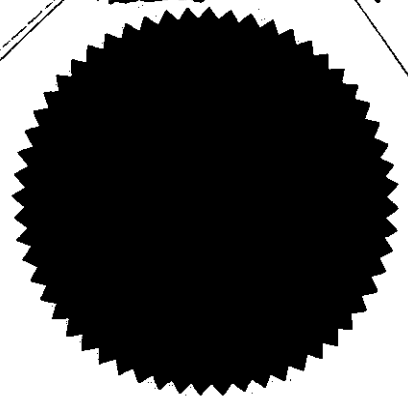
The footpath commences at OS grid reference SE 89342394 and proceeds in a south-westerly direction on a 2.5 metre wide grass headland across OS field parcel no. 3351, for a distance of 300 metres to OS grid reference SE 89552372.
