Definitive Map Modification (Public Footpath 317, Winteringham) Order 2005(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 3rd May 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 317, Winteringham) Order 2005(1).

Description of path to be deleted

A – B as indicated on the map: A 108-metre-long footpath commencing at Low Burgage Road at a point adjacent to and south of a dwelling known as Stone Lea at grid reference SE9328022388, proceeding in a north-westerly direction to its junction with Ferry Lane at grid reference SE9317922427.

Variation of particulars of path

A 66-metre-long footpath with a width of three metres commencing at a point west of a property known as The Hollies on Water Lane at grid reference SE9072020905, proceeding first along the drive of a property known as Leybourne House, then along the western boundary of some farm buildings in a south-south-easterly direction to a point along the farm buildings and the south side of a boundary hedge of a property known as Leybourne House at grid reference SE9073520855, and then along the south side of the same boundary hedge in a south-westerly direction to its junction with the existing footpath at grid reference SE9072320845.

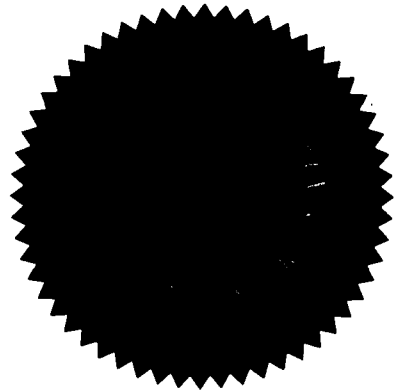

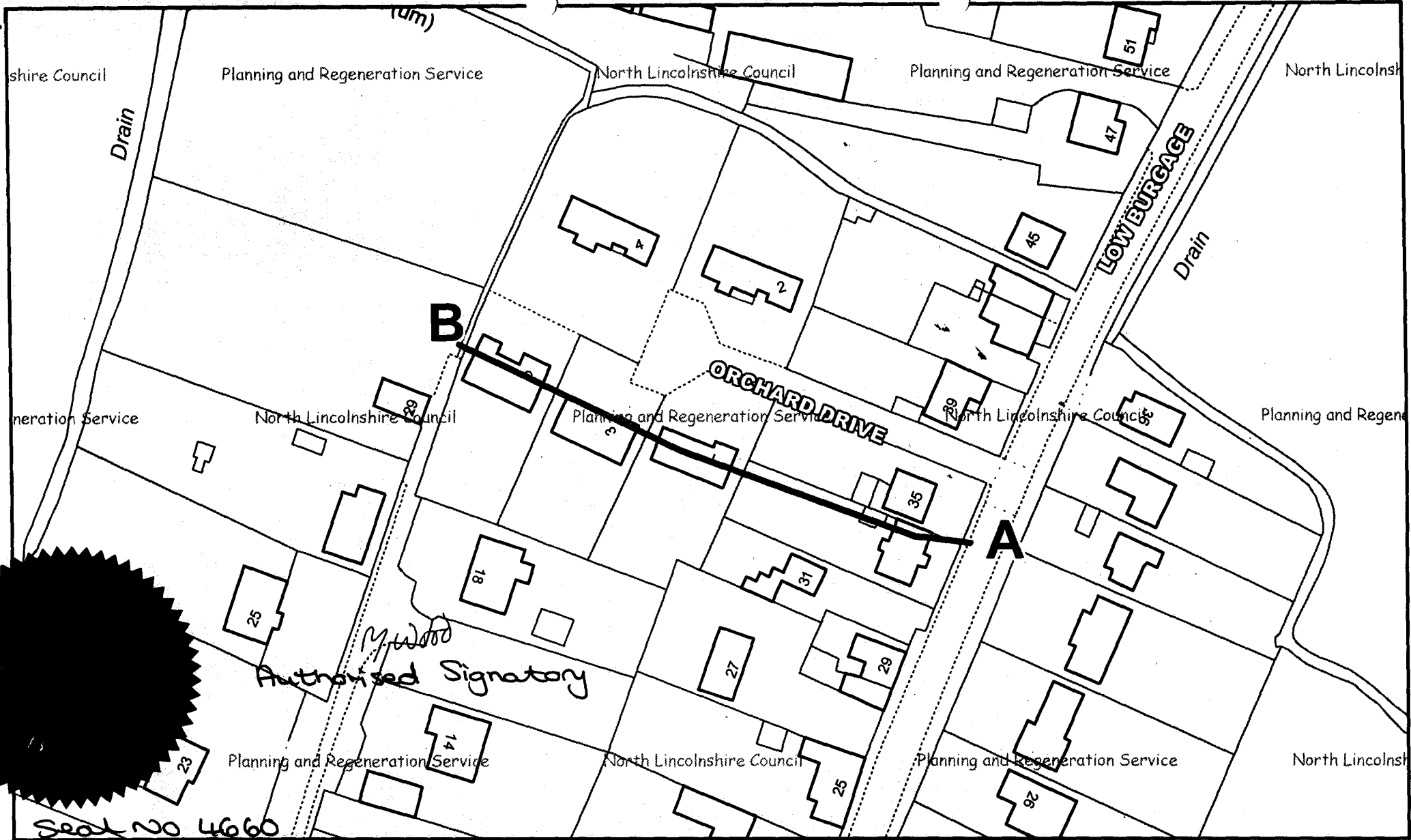
