Definitive Map Modification (Public Footpath 141, Worlaby) Order 2005(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 25 February 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 141, Worlaby) Order 2005(1).

SCHEDULE

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be deleted

A – B as indicated on the map: A 48-meter-long footpath commencing at grid reference TA0129113839 proceeding from a point on the existing footpath in a south-south-easterly direction to the junction with Low Road at grid reference TA0130813797.



Description of path to be added

A – C as indicated on the map: A 46-metre-long footpath with a width of 6 feet commencing at grid reference TA0129113839 proceeding from a point on the existing footpath first in a westerly then south-south-easterly direction to the junction with Low Road at grid reference TA0130013794.

PART 2

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement

Variation of particulars of path

A 94-metre-long footpath with a width of 6 feet commencing on the existing footpath and the north side of a boundary fence of a property known as No.58 Low Road at grid reference TA0129113839 proceeding in a first westerly then south-south-easterly direction along the western side of a boundary fence of the same property and the eastern side of a boundary fence of a property known as No.60 Low Road to the junction with Low Road at grid reference TA0130013794.

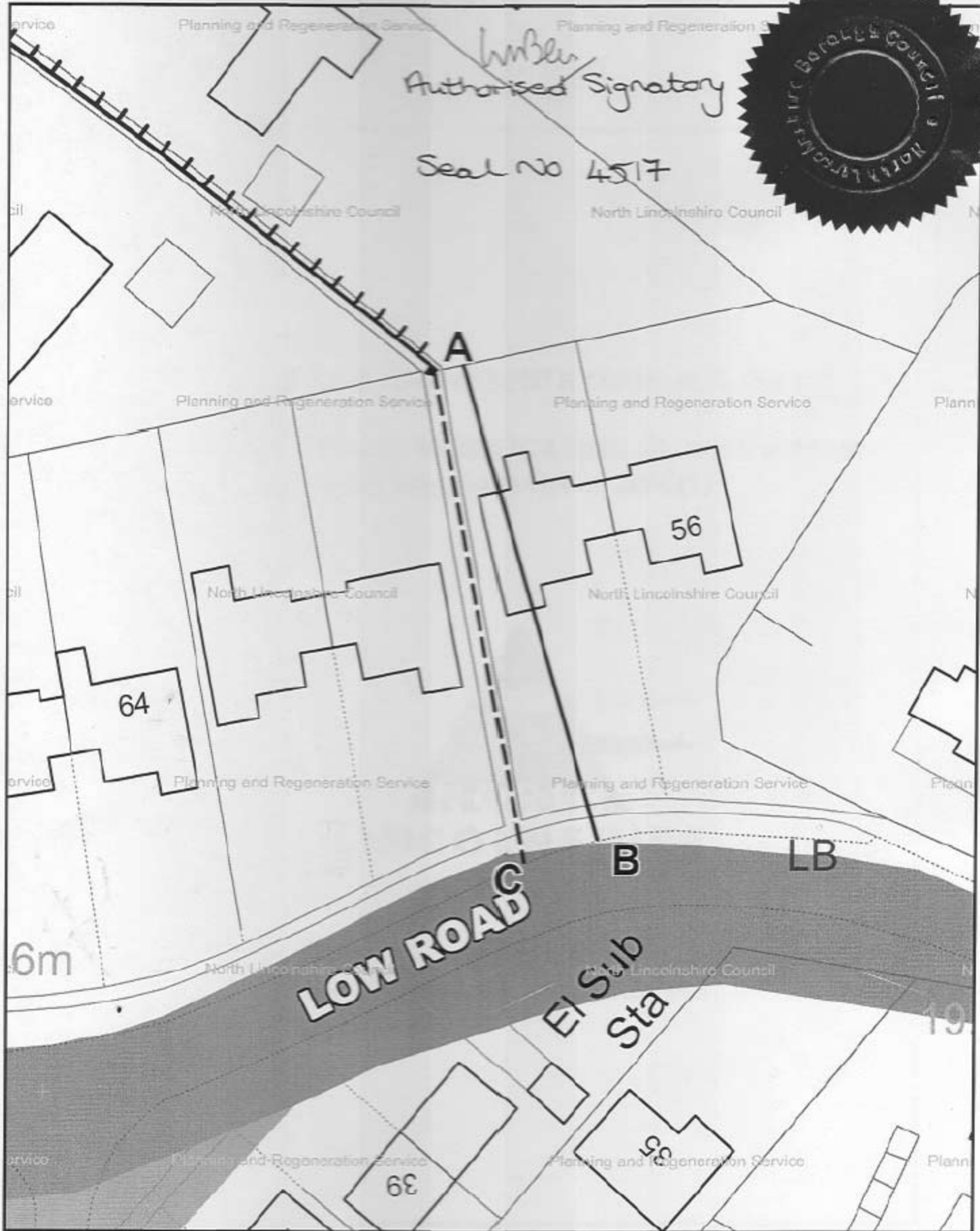
