Public Footpath 153, Wroot, Definitive Map Modification Order 2000

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Isle of Axholme) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(iii), namely, the coming into operation of any enactment or instrument, or any other event, whereby a new right of way has been created over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, of the Act.

The authority have consulted with every local authority whose area includes the land to which the order relates. The North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 16th. June 2000.
2. The County of Lincoln – Parts of Lindsey (Isle of Axholme) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date on which it is made and may be cited as the Public Footpath 153, Wroot, Definitive Map Modification Order 2000.

SCHEDULE

PART 1

Modification of Definitive Map

Description of path or way to be added

An approximately 1,730-metre-long footpath, two metres wide throughout, leading along the northern floodbank of the River Torne, Wroot, for 1,630 metres between Point A and Point C, then south for 50 metres across a footbridge to Point D, then east for 50 metres to Point E as indicated on the map.

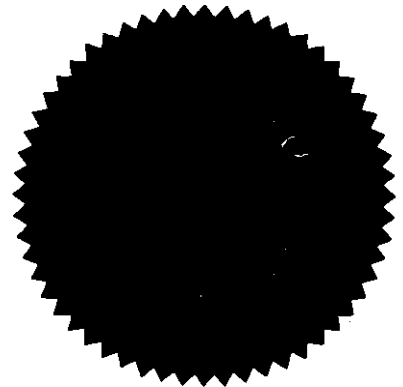
PART 2

Modification of Definitive Statement

Variations of particulars of path or way

From Public Bridleway 81, immediately north of the footbridge over the River Torne at grid reference SE70750378, the path leads east along the River Torne's northern floodbank for 1,630 metres to a wooden footbridge, which connects the north and south banks of the River Torne, at grid reference SE72300423; then turns south over said wooden footbridge for 50 metres to grid reference SE72310420, then continues east for a further 50 metres to join the northern end of Public Footpath 151 at grid reference SE72380419.
