"Definitive Map Modification (Public Footpath 2, Scunthorpe) Order 2013(2)"

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln, Parts of Lindsey (Glanford Brigg), Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(iii) – namely, a new right of way has been created over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path or restricted byway – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 16 December 2013.
2. The County of Lincoln, Parts of Lindsey (Glanford Brigg), Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the "Definitive Map Modification (Public Footpath 2, Scunthorpe) Order 2013(2)".

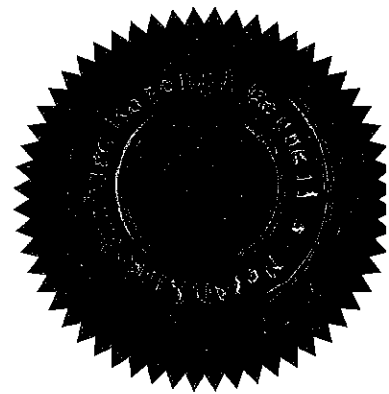

PART I

Modification of Definitive Map

Description of path or way to be added

A – B, as indicated on the map: an approximately 900-metre-long footpath proceeding from a point along Lakeside Parkway at grid reference SE91650790 opposite the pumping station close to the Whimbrel Chase roundabout generally eastwards to a point adjacent to the north-south stretch of Bottesford Beck about 90 metres east south east of the south-east corner of Ashby Ville Pond at grid reference SE92500790.

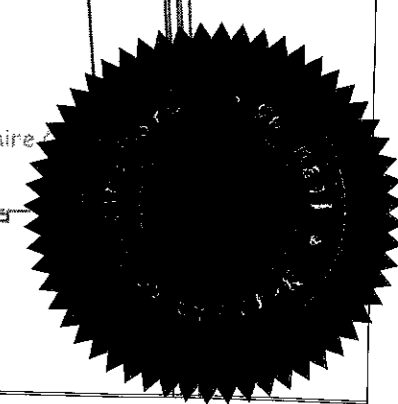
Modification of Definitive Statement

An approximately 900-metre-long footpath of a width of two metres throughout proceeding from a terminus a quo along Lakeside Parkway at grid reference SE91650790 opposite the pumping station close to the Whimbrel Chase roundabout generally eastwards to a terminus ad quem adjacent to the north-south stretch of Bottesford Beck about 90 metres east south east of the south-east corner of Ashby Ville Pond at grid reference SE92500790.
