Wildlife and Countryside Act 1981

County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement

"Definitive Map Modification (Public Footpath, Goxhill 56) Order 2006 (1)"

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) – namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way to which this Part applies – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 21st August 2006.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is confirmed and may be cited as the "Definitive Map Modification (Public Footpath, Goxhill 56) Order 2006 (1)".

SCHEDULE

PART I

Modification of Definitive Map

Description of path or way to be added

A – B, as indicated on the map: A 129-metre-long grassed footpath commencing on Gatehouse Road, proceeding from grid reference TA1011520742 in a south-south-westerly direction to the west of a hedge to grid reference TA1007620619, with a width of 1.8 metres throughout.



B – C, as indicated on the map: A 100-metre-long grassed footpath continuing from grid reference TA1007620619 in a south–south-westerly direction to the west of a hedge to grid reference TA1004620523, with a width of 1.8 metres throughout.

C – D, as indicated on the map: A 68-metre-long grassed footpath continuing from grid reference TA1004620523 in a south–south-westerly direction to the west of a hedge to grid reference TA1002620459, with a width of 1.8 metres throughout.

PART II

Modification of Definitive Statement

Variation of particulars of path or way

A rectilinear footpath of a length of 297 metres and a width of 1.8 metres commencing at a point on Gatehouse Road opposite Crossing Cottage at grid reference TA1011520742 and proceeding in a south–south-westerly direction along the lengths of the eastern boundaries of three enclosures that lie immediately west of the the access drive from Gatehouse Road to the property known as Hallands Field Farm to a further point at grid reference TA1002620459, this being 7.5 metres west of the north-western corner of the collection of buildings that comprise Hallands Field Farm.
