## Wildlife and Countryside Act 1981

### County of Lincoln – Parts of Lindsey (Isle of Axholme) Definitive Map and Statement

#### "Definitive Map Modification (Public Footpath 49, Epworth) Order 2006(2)"

This order is made by North Lincolnshire Council under section 53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Isle of Axholme) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map and statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

1. For the purposes of this order the relevant date is 17<sup>th</sup> February 2006.
2. The County of Lincoln – Parts of Lindsey (Isle of Axholme) Definitive Map and Statement shall be modified as described in the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the "Definitive Map Modification (Public Footpath 49, Epworth) Order 2006(2)".

#### SCHEDULE

##### Modification of Definitive Map

##### *Description of path or way to be deleted*

*A – B, as indicated on the map:* An approximately 112-metre-long footpath running in a north-westerly direction from and to the north of Station Road between grid references SE77510444 and SE77430452, the former being on Station Road at the south-east corner of No. 40B, Station Road, and the latter being where the extant line of Public Footpath 49 makes a right-angled turn adjacent to the old Sunday School.

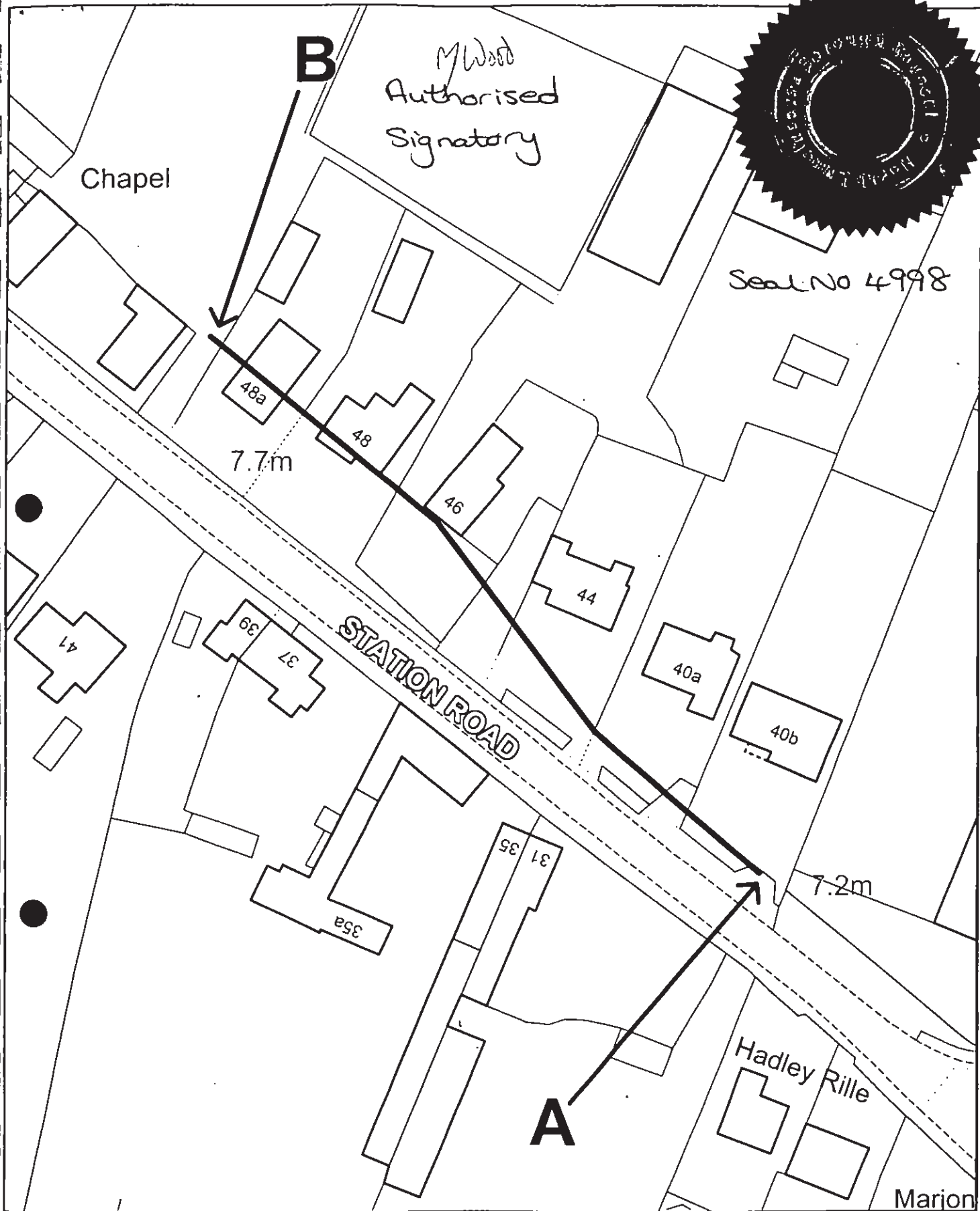
