DEFINITIVE MAP MODIFICATION ORDER
WILDLIFE AND COUNTRYSIDE ACT 1981

Wildlife and Countryside Act 1981

County of Lincoln – Parts of Lindsey (Isle of Axholme) Definitive Map and Statement

"Definitive Map Modification (Public Footpath 80, Wroot) Order 2007 (1)"

This order is made by North Lincolnshire Council under section 53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Isle of Axholme) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event whereby a highway shown or required to be shown in the map and statement has been authorised to be stopped up, diverted, widened, or extended, or of the Act.

North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 14th February 2007.
2. The County of Lincoln – Parts of Lindsey (Isle of Axholme) Definitive Map and Statement shall be modified as described in Parts I and II of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date confirmed and may be cited as the "Definitive Map Modification (Public Footpath 80, Wroot) Order 2007 (1)".
