**Definitive Map Modification (Public Footpath 1, Alkborough) Order 2005(1)**

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 3<sup>rd</sup> May 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 1, Alkborough) Order 2005(1).

PART 2

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement

Variation of particulars of path

A 2549-metre-long footpath commencing on the existing footpath on Alkborough Flatts Lane at a point adjoining the western boundary of the Sewage Works Compound at grid reference SE8792022121, proceeding along the route of Alkborough Flatts Lane in a north-westerly direction to the southern boundary of O.S. Field number 8974 at grid reference SE8710022608, and then along the southern boundary of O.S. Field number 8974 in a north-west-westerly direction to the south bank of the River Humber at grid reference SE8664322700, and then along the south bank of the River Humber in a first northerly then north-easterly direction to a point on the existing footpath in line with the boundary between O.S. Fields numbered 2117 and 0058 at grid reference SE8719023319. The footpath has a minimum width of 1.22 metres throughout.

### PART 1

#### Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

##### Description of path to be deleted

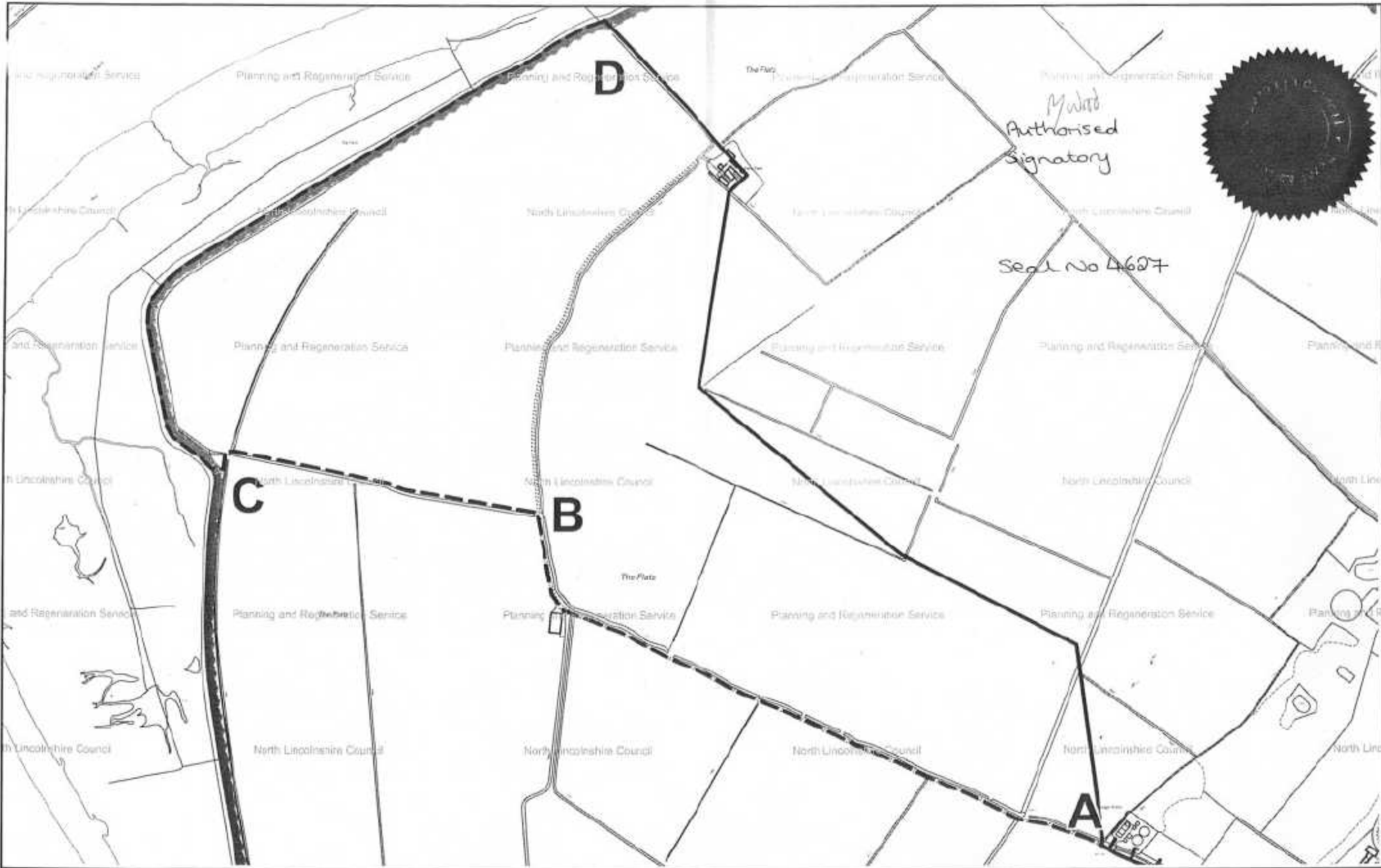
*A – D as indicated on the map:* A 1630-metre-long footpath commencing on the existing footpath on Alkborough Flatts Lane at a point adjoining the western boundary of the Sewage Works Compound at grid reference SE8792022121, proceeding over O.S. Fields numbered 0024, 7951, 4866, 3300, 3810 (Flatts Farmyard) and 2117 in a north-westerly direction to a junction on the existing footpath on the South Bank of the River Humber at grid reference SE8719023319.

##### Description of path to be added

*A – B as indicated on the map:* A 1013-metre-long footpath with a width of 1.22 metres commencing on the existing footpath on Alkborough Flatts Lane at a point adjoining the western boundary of the Sewage Works Compound at grid reference SE8792022121, proceeding along the route of Alkborough Flatts Lane in a north-westerly direction to the southern boundary of O.S. Field number 8974 at grid reference SE8710022608.

*B – C as indicated on the map:* A 456-metre-long footpath with a width of 1.22 metres commencing on the southern boundary of O.S. Field number 8974 at grid reference SE8710022608, proceeding along the southern boundary of O.S. Field number 8974 in a north-west-westerly direction to the south bank of the River Humber at grid reference SE8664322700.

*C – D as indicated on the map:* A 1080-metre-long footpath with a width of 1.22 metres commencing on the south bank of the River Humber at grid reference SE8664322700, proceeding along the south bank of the River Humber in a first northerly then north-easterly direction to a point on the existing footpath in line with the boundary between O.S. Fields numbered 2117 and 0058 at grid reference SE8719023319.
