**Definitive Map Modification (Public Footpath 145, Barnetby-le-Wold)
Order 2005(1)**

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 16th May 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 145, Barnetby-le-Wold) Order 2005(1).

SCHEDULE

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be deleted

A – C as indicated on the map: An 80-metre-long footpath commencing at Low Farm at grid reference TA0565409657, proceeding in a south-easterly direction for 25 metres to grid reference TA0567609647 and then in a south-westerly direction for 55 metres around Low Farm to grid reference TA0564809599.

Description of path to be added

A – B as indicated on the map: A 58-metre-long footpath with a width of 2.4 metres commencing at Low Farm at grid reference TA0565409657, proceeding along a cart track on the western boundary of Low Farm in a south-westerly direction to grid reference TA0562609607.

B – C as indicated on the map: A 25-metre-long footpath with a width of 2.4 metres commencing at grid reference TA0562609607, proceeding along the southern boundary of Low Farm in an easterly direction to grid reference TA0564809599.

PART 2

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement

Variation of particulars of path

An 83-metre-long footpath with a width of 2.4 metres commencing at grid reference TA0565409657, proceeding for 58 metres along a cart track on the western boundary of Low Farm in a south-westerly direction to grid reference TA0562609607 changing to run along the southern boundary of Low Farm in an easterly direction to grid reference TA0564809599.

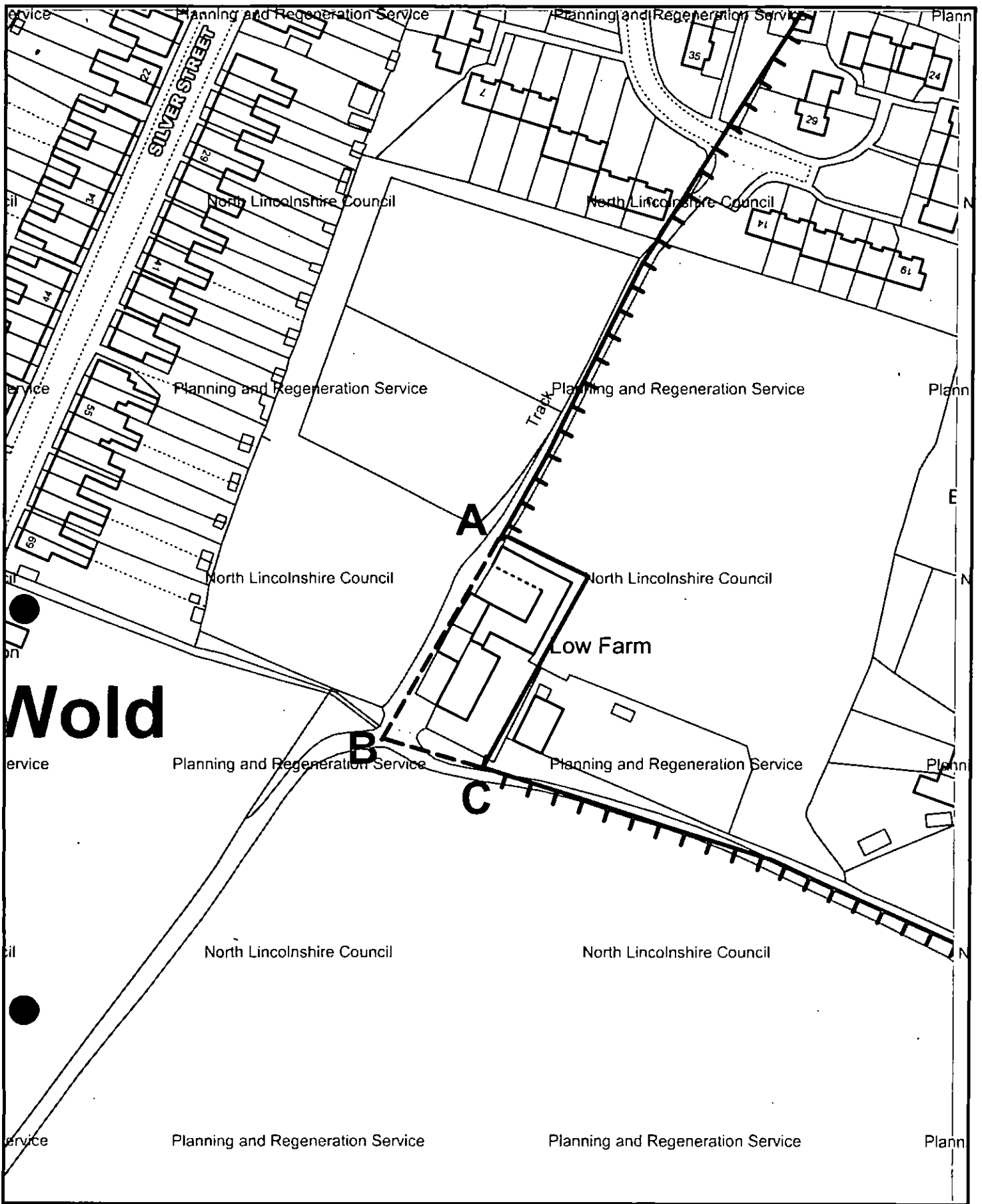
