## Wildlife and Countryside Act 1981

### County of Lincoln – Parts of Lindsey Definitive Map and Statement Footpath 31, Belton, Definitive Map Modification Order 2000

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i), namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended, of the Act.

The authority have consulted with every local authority whose area includes the land to which the order relates. The North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 14<sup>th</sup>. June 2000.
2. The County of Lincoln – Parts of Lindsey Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Footpath 31, Belton, Definitive Map Modification Order 2000.

#### SCHEDULE

##### PART 1

###### Modification of Definitive Map

###### Description of path to be deleted

Public Footpath No. 31, Parish of Belton, having a length of 105 metres and running in an easterly direction for 90 metres from Point A, via its junction with Public Footpath No. 33, to Westgate Road, 5 metres west of Point D.

###### Description of path to be added

A 2-metre-wide public footpath, running in an easterly direction for 88 metres from Point A to its junction with Public Footpath 33 at Point B, then continuing in an easterly direction for a further 3 metres to Point C, before turning north for 31 metres to Point D on Westgate Road.

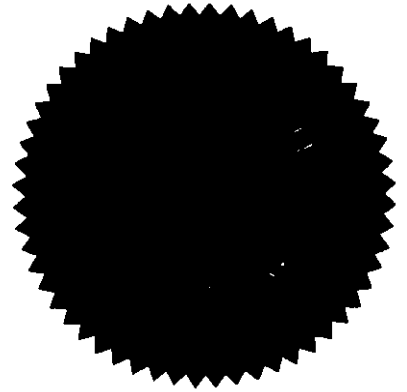
Modification of Definitive Statement

Variation of particulars of path

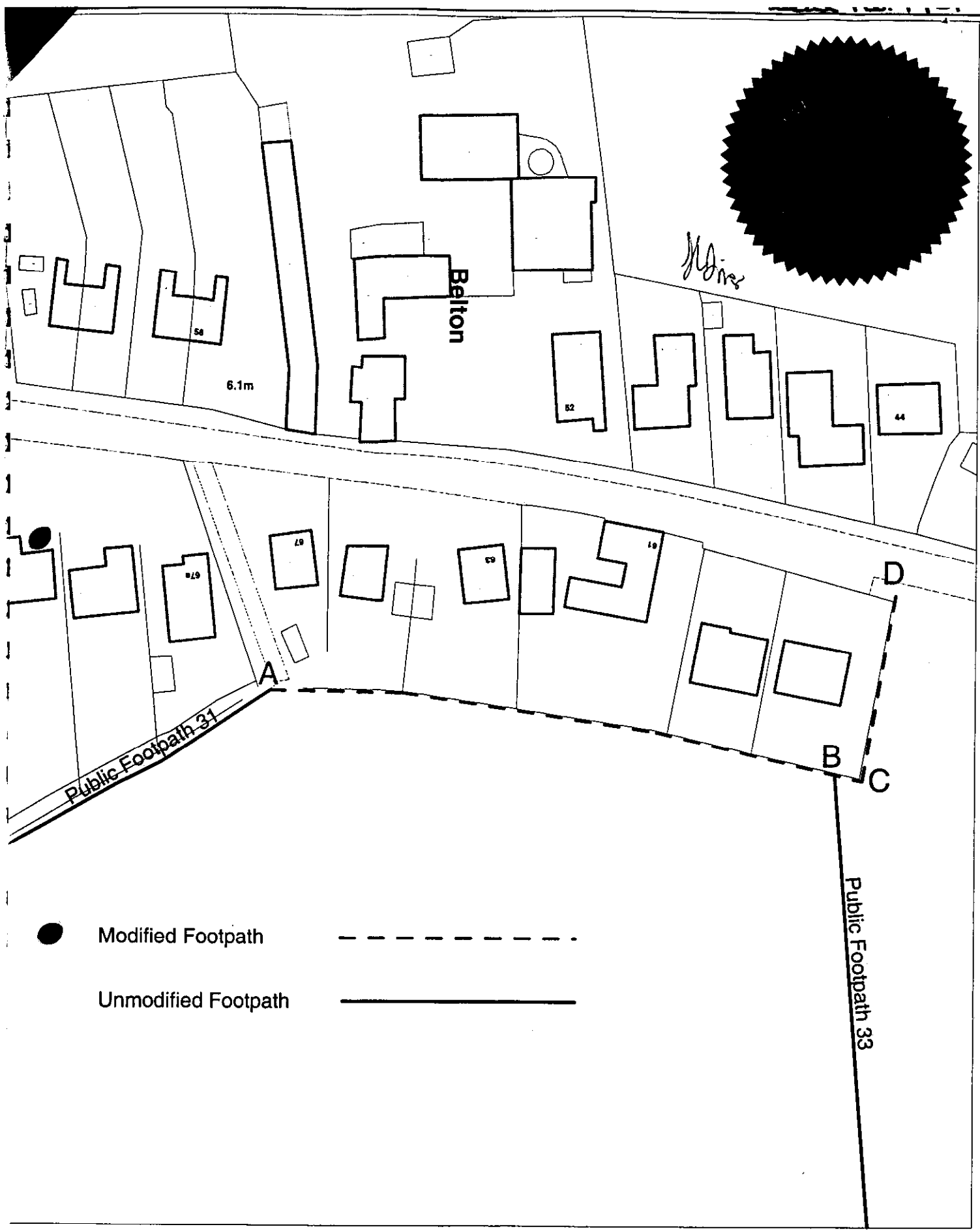
From grid reference SE7798407387 the path heads east from the southern end of a 36-metre-long track that runs to the west of property number 67, Westgate Road, to follow the edge of the field immediately to the south of property numbers 67, 65, 63, 61, 59 and 57, Westgate Road, for 88 metres to grid reference SE7807107374 , this being its junction with the northernmost end of Public Footpath 33, then continues east for 3 metres to grid reference SE7807407373, then turns north along a western edge of the same field as before immediately east of property number 57, Westgate Road, for 31 metres to grid reference SE7808007404 on Westgate Road, immediately east of the frontage of property number 57, Westgate Road.
