County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement

Definitive Map Modification (Public Footpath 142, Bonby) Order 2005(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 (the Act) because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 25 February 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 142, Bonby) Order 2005(1).

SCHEDULE

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be deleted

A – B as indicated on the map: A 92-metre-long footpath commencing on Worlaby Road at grid reference TA0052414875, that runs diagonally across and to the eastern boundary of the enclosure known as Southfield in a north-easterly direction to grid reference TA0053114950.

Description of path to be added

A – C as indicated on the map: A 41-metre-long footpath with a width of 4 feet commencing on Worlaby Road some 14 metres south of the enclosure named Southfield at grid reference TA0052414875, proceeding along the eastern boundary of a property known as 16 Worlaby Road in a north-easterly direction to the eastern side of the boundary of the same property at grid reference TA0056014891.

C – D as indicated on the map: A 15-metre-long footpath with a width of 4 feet commencing at the eastern side of the boundary of a property known as 16 Worlaby Road at grid reference TA0056014891, proceeding along the east side of the boundary of the same property in a northerly direction to the south side of the boundary of a property known as Southfield at grid reference TA0055614906.

D – E as indicated on the map: A 43-metre-long footpath with a width of 4 feet commencing at the south side of the boundary of a property known as Southfield at grid reference TA0055614906, proceeding along the south side of the same boundary in a north-east-easterly direction to the north-eastern corner of the same boundary at grid reference TA0059414924.

E – B as indicated on the map: A 22-metre-long footpath with a width of 4 feet commencing at the north-eastern side of the boundary of a property known as Southfield at grid reference TA0059414924, proceeding along the east side of the boundary of the same property in a north-westerly direction to a point midway along the boundary and the existing footpath at grid reference TA0058114950.

PART 2

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Variation of particulars of path

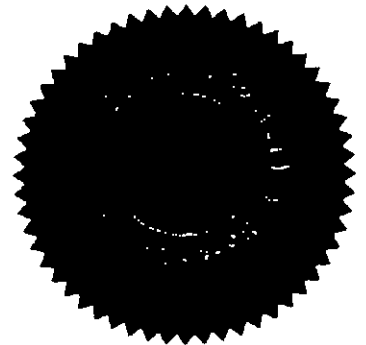
A 121-metre-long footpath commencing on Woraby Road at the south west corner of a property known as 16 Woraby Road at grid reference TA0052414875, proceeding along the southern boundary of the same property in a north-easterly direction to the east side of the boundary at grid reference TA0056014891, and then along the east side of the same boundary in a northerly direction to the south side of the boundary of a property known as Southfields at grid reference TA0055614906, and then along the south side of the same boundary in a north-easterly direction to the north-eastern corner of the boundary to grid reference TA0059414924, and then along the east side of the same boundary in a north-westerly direction to a point midway along the boundary and the existing footpath at grid reference TA0058114950. The footpath has a minimum width of 4 feet throughout.

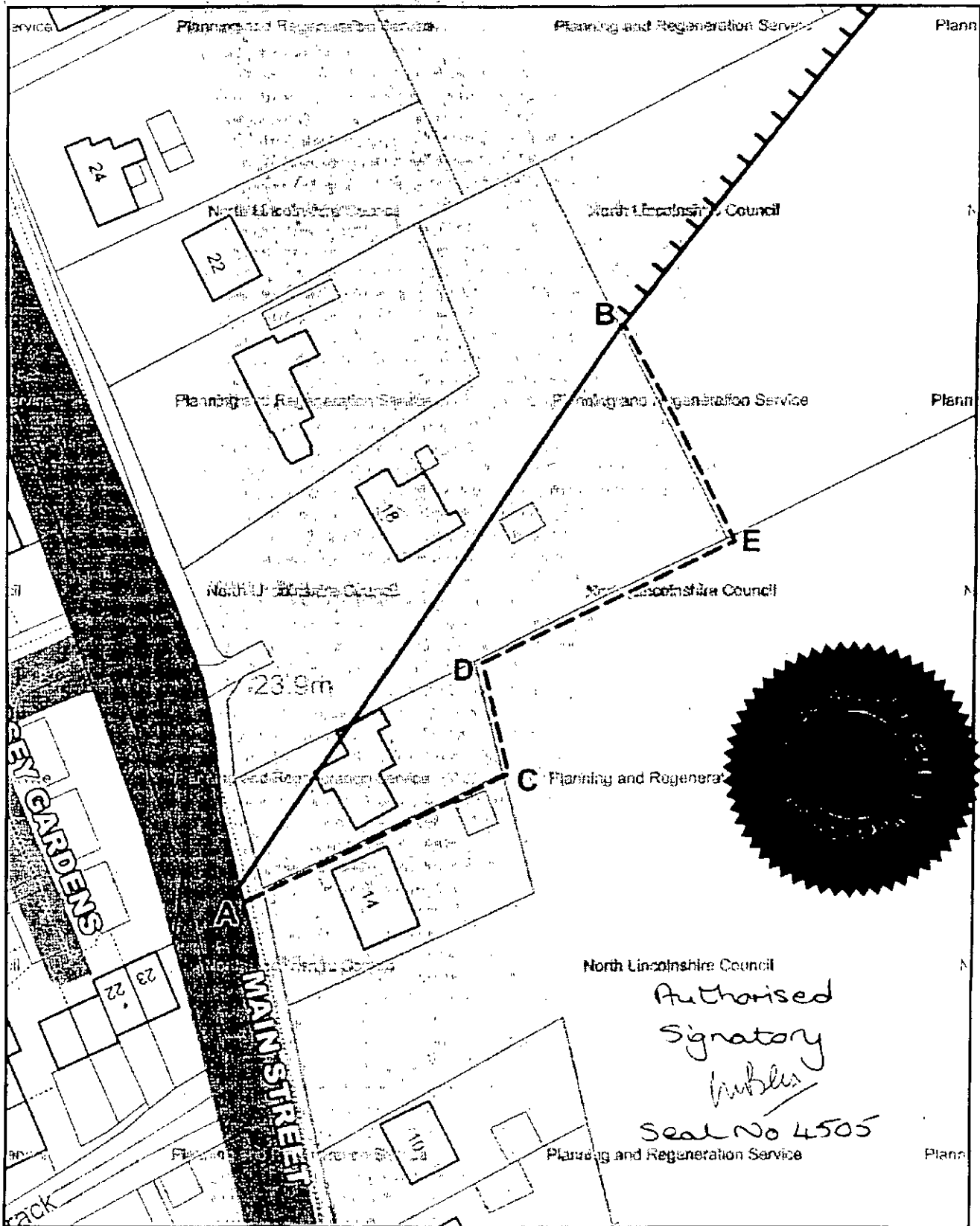
