## **Wildlife and Countryside Act 1981**

### **County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement**

#### **Definitive Map Modification (Bottesford FP 196) Order 2012 (1)**

This order is made by North Lincolnshire Council under section 53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map and statement has been authorised to be stopped up, diverted, widened or extended.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 23 January 2012.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Bottesford FP 196 Order 2012 (1)).

## SCHEDULE

### PART 1

#### Modification of Definitive Map

##### *Description of path or way to be deleted*

A – B as indicated on the map: An 860-metre-long footpath leading from a point adjoining public footpath 199 at grid reference SE89810705 and leading south-west to its junction with Messingham Road at grid reference SE89130660.

##### *Description of path or way to be added*

C – D as indicated on the map: A 427-metre-long footpath commencing at its junction with public footpath 199 and Church Lane at grid reference SE89820704 leading generally south-south-west along a 1.22-metre-wide track between properties, continuing along the track first in a southerly and then a more south-westerly direction to its junction with Valley View Drive at grid reference SE89610671.

E – F as indicated on the map: An 86-metre-long footpath leading from a point abutting Valley View Drive at grid reference SE89590670 leading west-south-westerly over a grassed area and then between properties to its junction with Worcester Close at grid reference SE89510667.

G – H as indicated on the map: A 547-metre-long footpath commencing at a point adjoining Valley View Drive at grid reference SE89560661, leading south along a track through Beckside Linear Park and continuing along the track in a generally south-westerly direction approximately 7 metres north of Bottesford Beck, leading to its junction with Messingham Road at grid reference SE89140635.

### PART 2

#### Modification of Definitive Statement

##### *Variation of particulars of path or way*

A 1,060-metre-long footpath with a width of 1.22 metres commencing at grid reference SE89820704 at its junction with public footpath 199 and Church Lane, leading generally south-south-west between properties, continuing along a track first in a southerly and then a more south-westerly direction to its junction with Valley View Drive at grid reference SE89610671. Re-commencing at grid reference SE89590670 and leading west-south-westerly over a grassed area and then between properties to its junction with Worcester Close at grid reference SE89510667, then commencing again at a point adjoining Valley View Drive at

grid reference SE89560661, leading south along a track through Beckside Linear Park and continuing along the track in a generally south-westerly direction approximately 7 metres north of Bottesford Beck, leading to its junction with Messingham Road at grid reference SE89140635.
