County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement

Definitive Map Modification (Public Footpath 283, Brigg) Order 2004(1)

This order is made by North Lincolnshire Council under section 53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 16 December 2004.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 283, Brigg) Order 2004(1).

SCHEDULE

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be deleted

Point A – C as indicated on the map: a 385-metre-long public footpath leading in a southerly direction from the field entrance at grid reference TA0143307841 to a footbridge across a drain at the southern boundary of the field at grid reference TA0142907456.

Description of path to be added

Point A – B as indicated on the map: a 323-metre-long public footpath from the field entrance at grid reference TA0143307841 leading in a south-easterly direction on the western side of the north-eastern boundary of the field to grid reference TA0161607576.

Point B – C as indicated on the map: a 61-metre-long public footpath from grid reference TA0161607576 leading in a south-south-easterly direction along the western side of the eastern boundary of the field to a junction with footpath 326 at grid reference TA0163207518.

Point C – D as indicated on the map: a 68-metre-long public footpath from its junction with footpath 326 at grid reference TA0163207518 leading in a south-south-easterly direction along the western side of the eastern boundary of the field to grid reference TA0164307450.

Point D – E as indicated on the map: a 212-metre-long public footpath from grid reference TA0164307450 leading in a westerly direction along the northern side of a drain to a footbridge over the drain at grid reference TA0142907456.

The footpath has a minimum width of 2 metres throughout.

PART 2

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement

Variation of particulars of path

A 2-metre-wide footpath commencing at the field entrance at grid reference TA0143307841 leading in a south-easterly direction for 323 metres on the western side of the north-eastern boundary of the field to grid reference TA0161607576 changing to a south-south-easterly direction along the western side of the eastern boundary of the field for 61 metres to its junction with footpath 326 at grid reference TA0163207518 and continuing for a further 68 metres to grid reference TA0164307450 whereupon it changes to a westerly direction along the northern side a drain to a footbridge at grid reference TA0142907456.

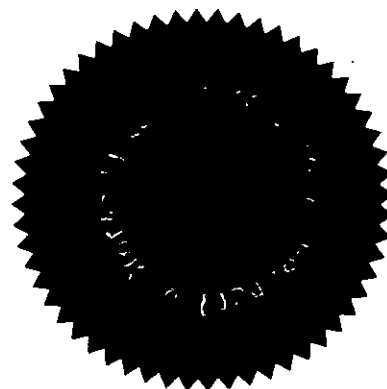

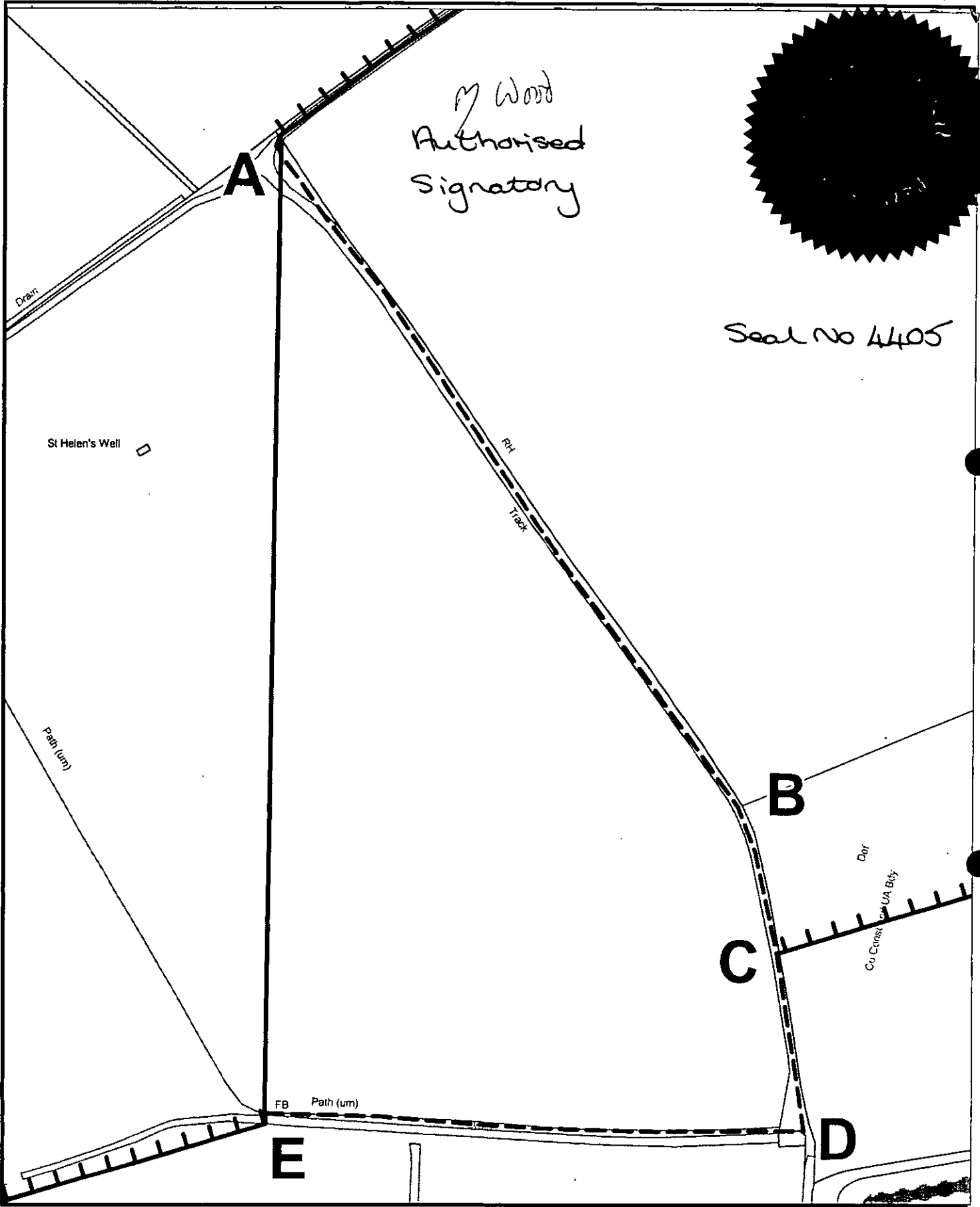
