### **County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement**

#### **Definitive Map Modification (Public Footpath 326, Brigg) Order 2004(1)**

This order is made by North Lincolnshire Council under section 53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 16 December 2004.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 326, Brigg) Order 2004(1).

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

*Description of path to be deleted*

Point A – B as indicated on the map: a 212-metre-long public footpath crossing a field in a east-north-easterly direction from a footbridge at its junction with public footpath 283 at grid reference TA0143007455 to the boundary of the field at grid reference TA0163207517.

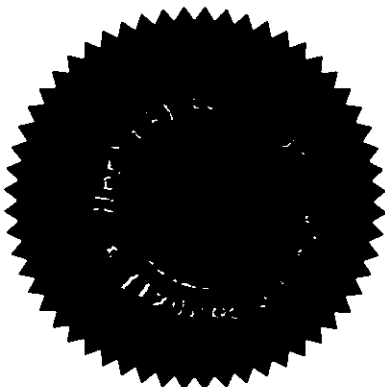

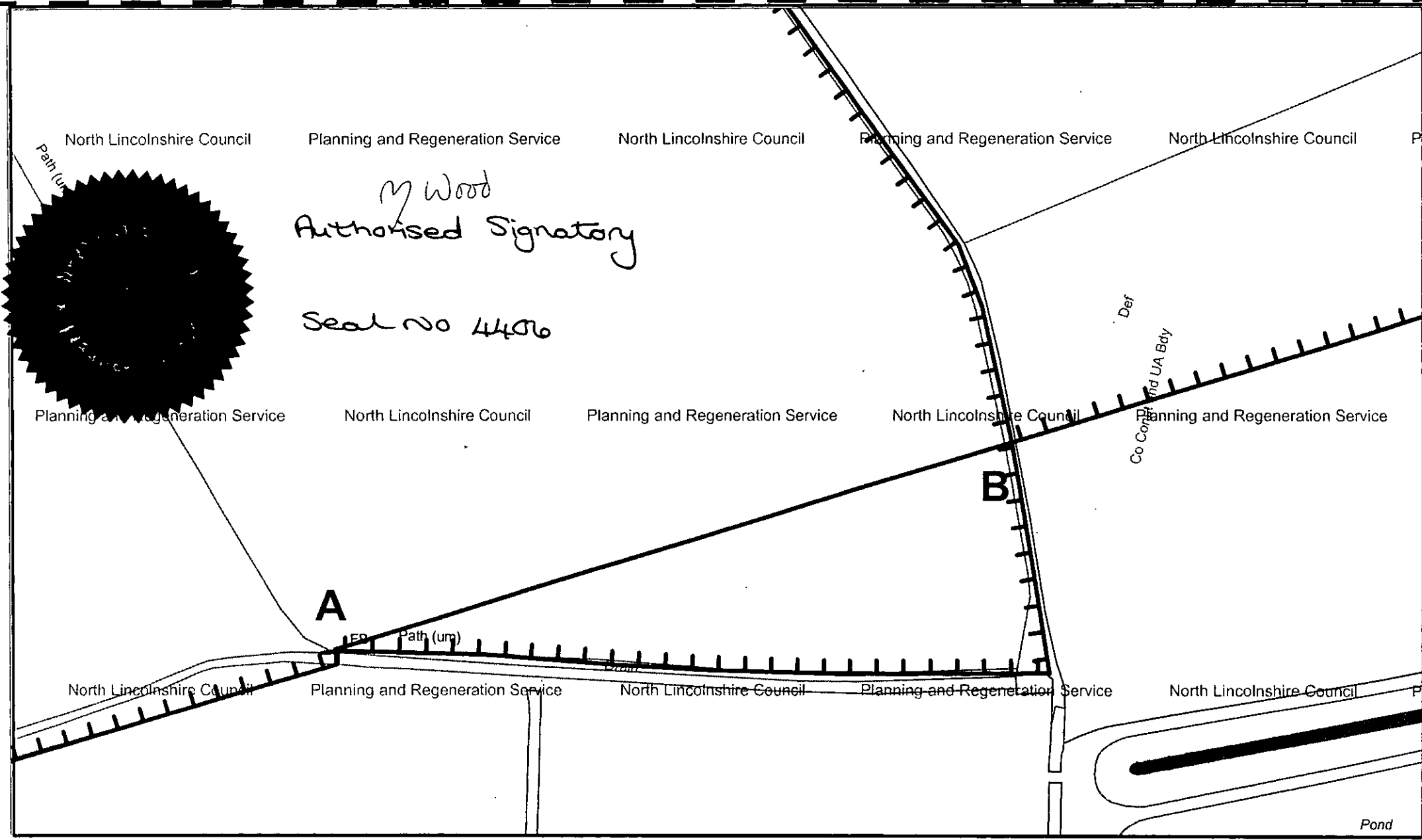
