Definitive Map Modification (Public Footpath 219B, Broughton) Order 2005(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) – namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way to which this Part applies – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 22nd September 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is confirmed and may be cited as the "Definitive Map Modification (Public Footpath 219B, Broughton) Order 2005(1)".

SCHEDULE

PART 1

Modification of Definitive Map

Description of path to be added

Point A to Point B, as indicated on the map by a dashed line: A 73-metre-long footpath with a minimum width of 2.5 metres leading in a northerly direction along a snicket from Airedale Close at grid reference SE9621909251 to Town Hill at grid reference SE9622409319.

PART 2

Modification of Definitive Statement

Variation of particulars of path

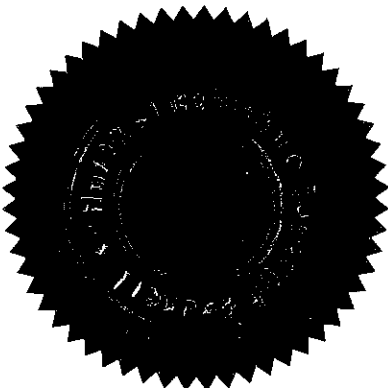
A 73-metre-wide footpath of a minimum width of 2.5 metres beginning at a point on Airedale Close at grid reference SE9621909251 and proceeding in a northerly direction along a snicket between property numbers 5 Airedale Close, 50 & 52 St. Bernard's Close and 61 Town Hill to its west and property numbers 6 Airedale Close and 59 Town Hill to its east to a point on Town Hill at grid reference SE9622409319.

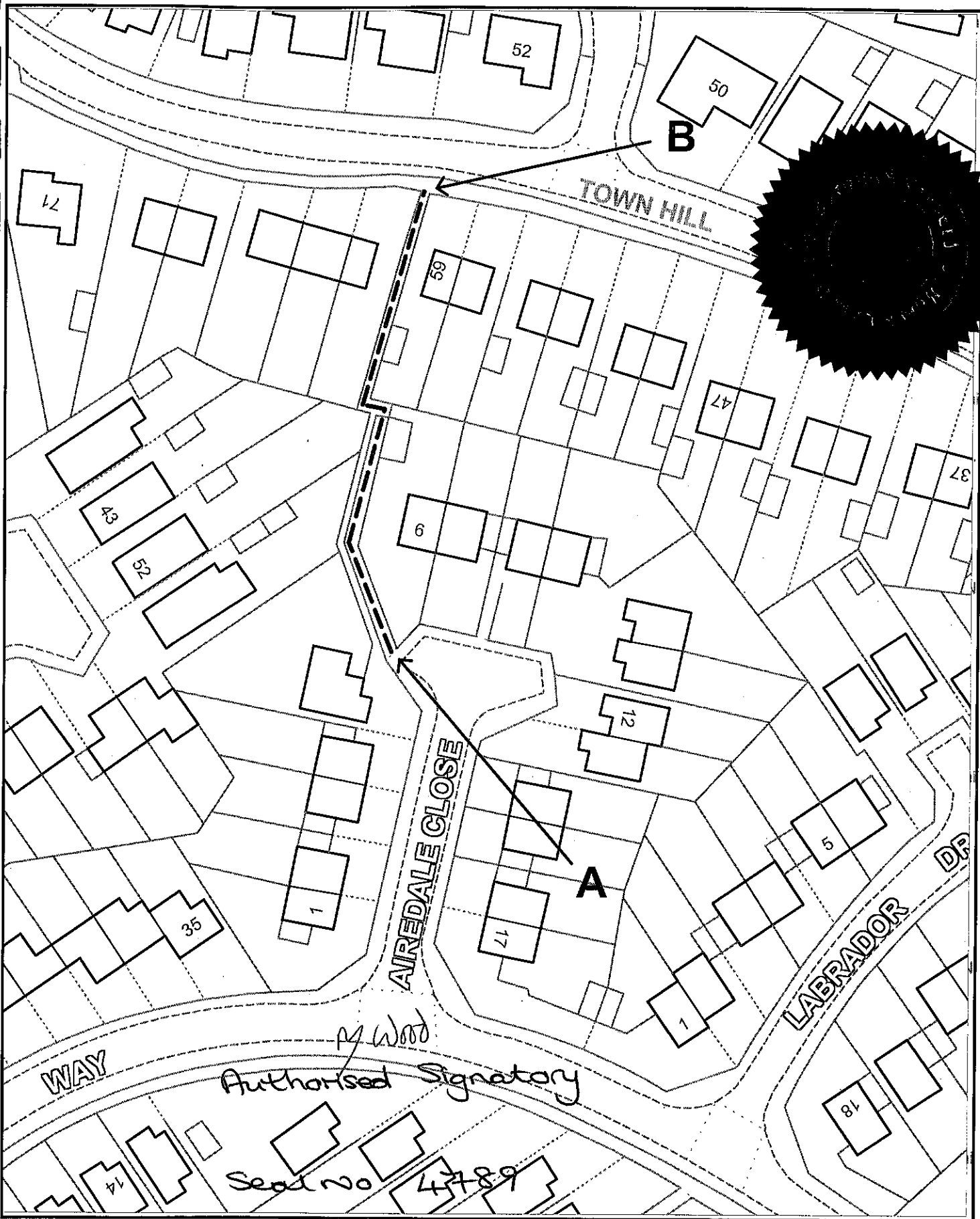
