"Definitive Map Modification (Public Footpath 219C, Broughton) Order 2006(1)"

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(iii) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a new right of way has been created over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path – of the Act.

1. For the purposes of this order the relevant date is 16th December 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the "Definitive Map Modification (Public Footpath 219C, Broughton) Order 2006(1)".

PART 1

Modification of Definitive Map

Description of path to be added

A – B, as indicated on the map: a 140-metre-long footpath with a width of 1.5 metres commencing adjacent to the easterly tip of the property at 2, Chestnut Grove, this being at grid reference SE9628309370, and proceeding in a north-westerly direction between the entire western boundary of the property known as Woodside on the one side and properties 2, 4, 6, 8, 12, Chestnut Grove, and 20 and 7, Rue de Nozay, on the other to a point to the rear of 5, Rue de Nozay at grid reference SE9620309485.

PART 2

Modification of Definitive Statement

Variation of particulars of path

A 140-metre-long footpath with a width of 1.5 metres commencing adjacent to the easterly tip of the property at 2, Chestnut Grove, this being at grid reference SE9628309370, and proceeding in a north-westerly direction between the entire western boundary of the property known as Woodside on the one side and properties 2, 4, 6, 8, 12, Chestnut Grove, and 20 and 7, Rue de Nozay, on the other to a point to the rear of 5, Rue de Nozay at grid reference SE9620309485.

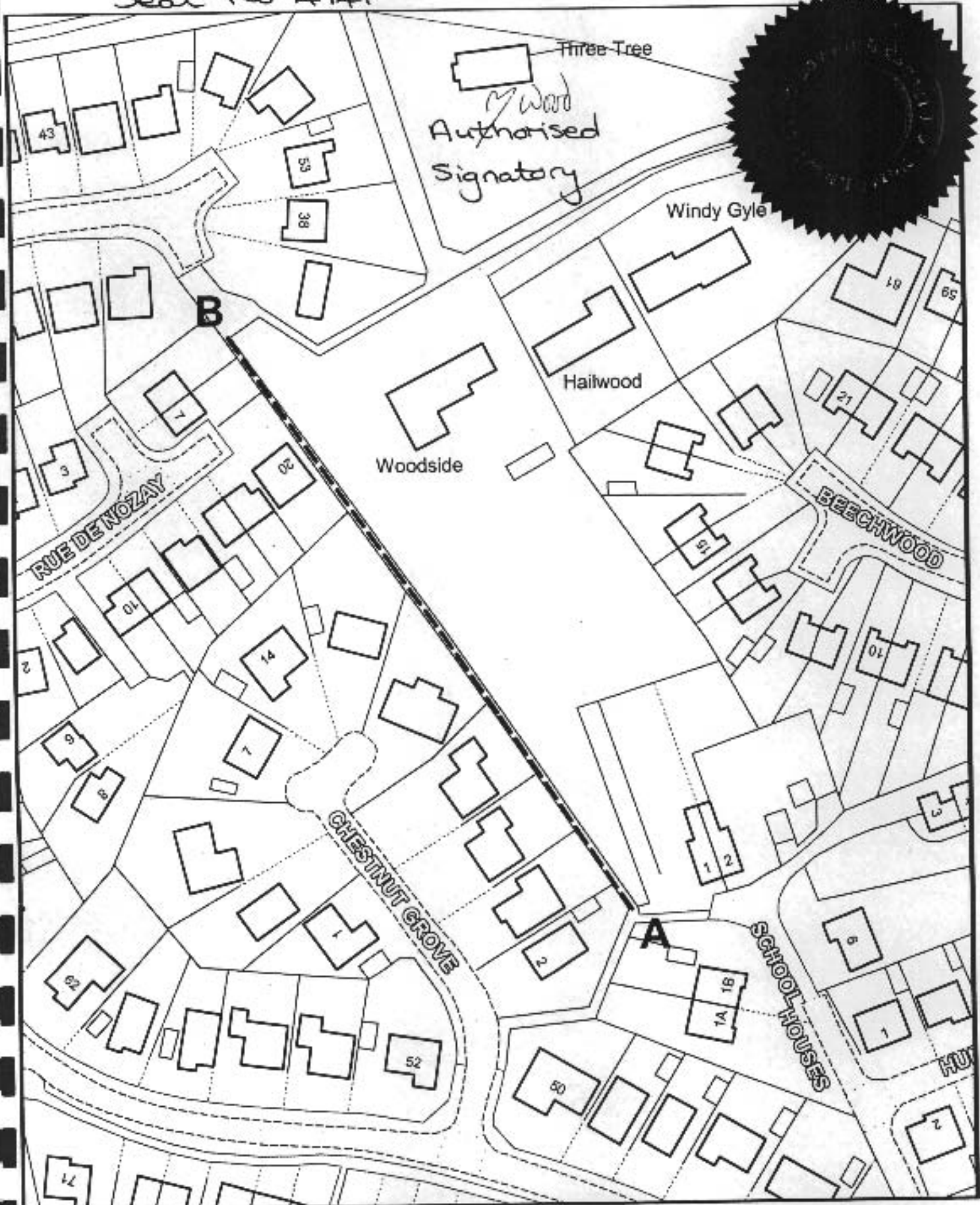
