**Definitive Map Modification (Broughton 224) Order 2011**

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(iii) – namely, that there is no public right of way over land shown in the map and statement as a highway of any description, or any other particulars contained in the map and statement require modification.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 21 October 2011.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is confirmed and may be cited as the Definitive Map Modification (Broughton 224) Order 2011.

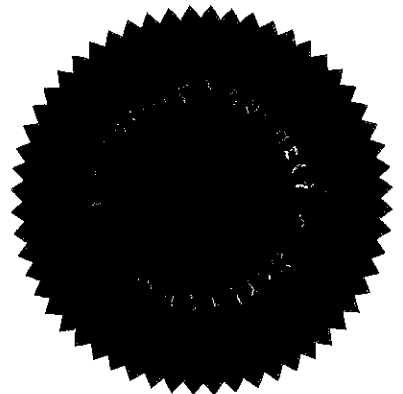

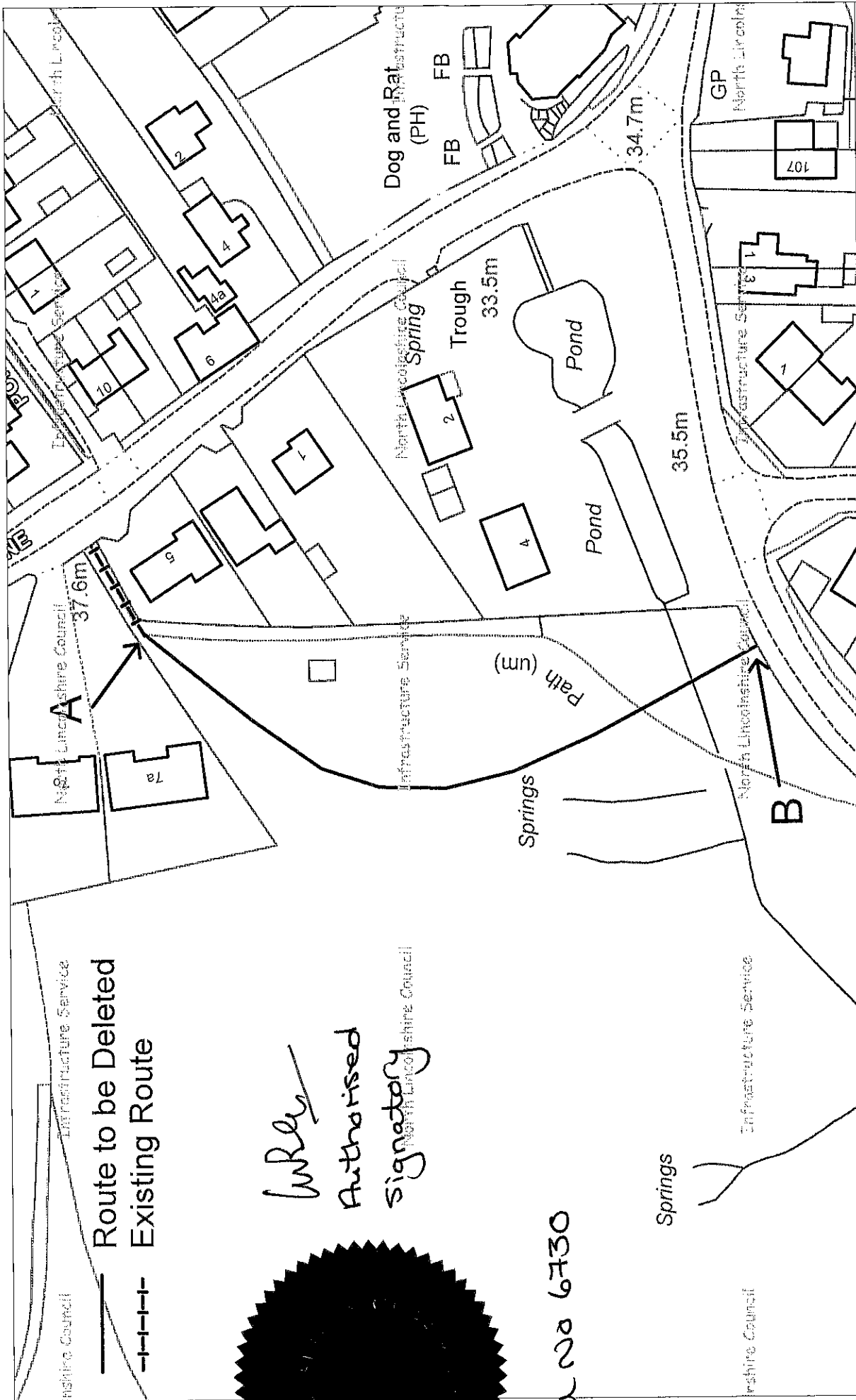
## SCHEDULE

##### *Description of path to be deleted*

*A – B as indicated on the map:* A 133-metre-long stretch of public footpath 224, commencing on the existing path at grid reference SE95640874 to the rear of a property at 5 Appleby Lane and running in a generally south-westerly direction over a mound and through a wooded area, following the mound round in a southerly and then south-easterly direction to its junction with Ermine Street at grid reference SE95630862.
