Definitive Map Modification (Broughton 224) Order 2011

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) – namely, that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 21 October 2011.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is confirmed and may be cited as the Definitive Map Modification (Broughton 224) Order 2011 (2).

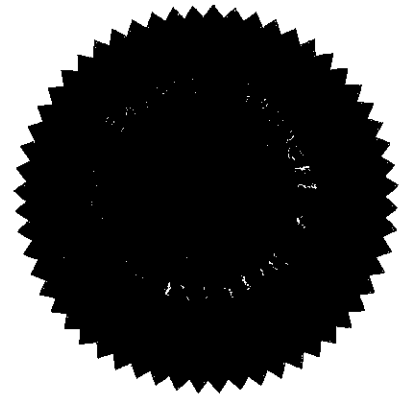

Modification of Definitive Map

Description of path or way to be added

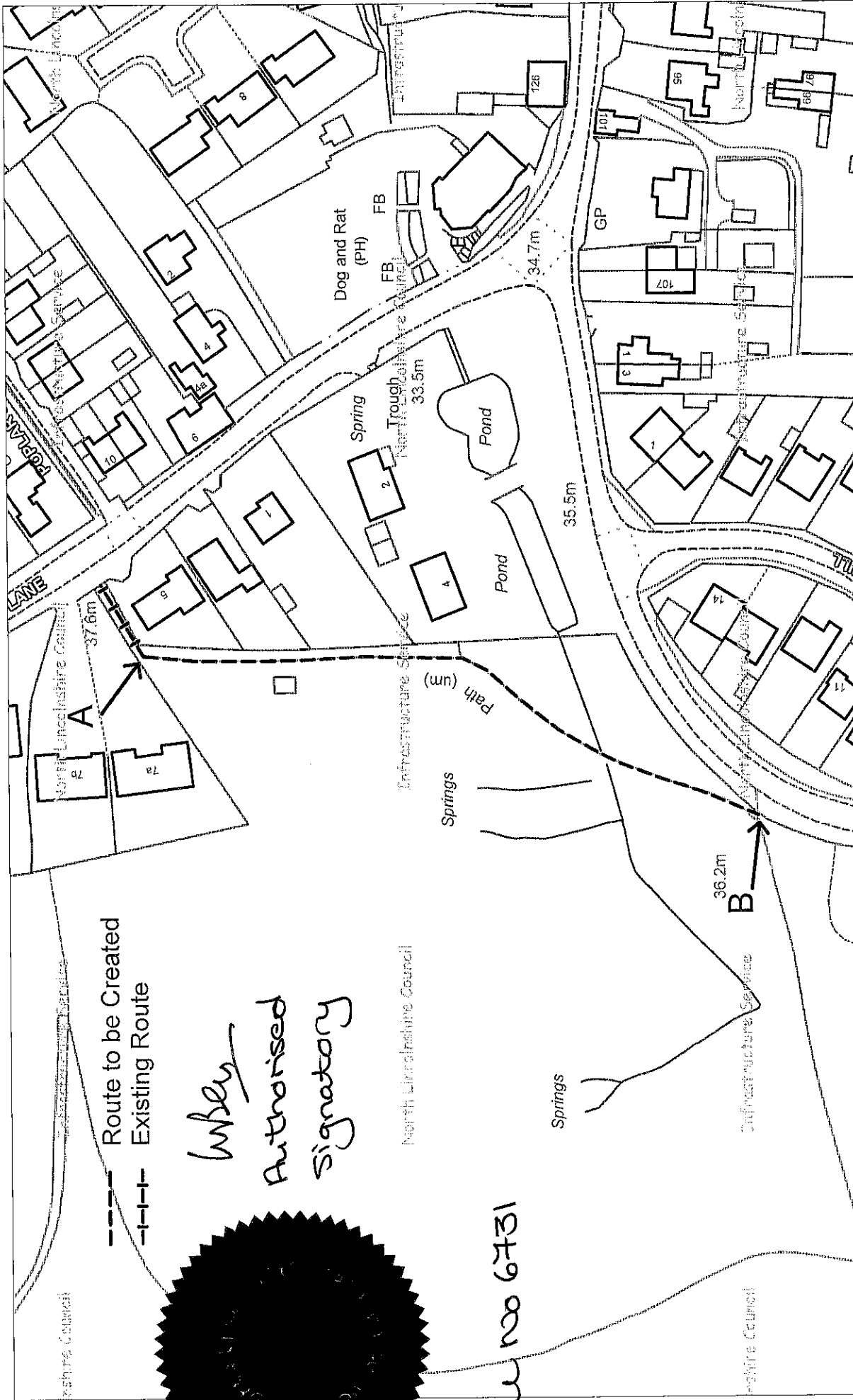
A – B as indicated on the map: A 161-metre-long footpath commencing at a point on the existing public footpath 224 at grid reference SE95640874 leading south along a worn track to the rear of properties on Appleby Lane, turning south-west, crossing a spring and continuing to its junction with public footpath 212 and Ermine Street at grid reference SE95600859.

PART 2

Modification of Definitive Statement

Variation of particulars of path or way

A 180-metre-long footpath with a width of 1.8 metres commencing at a point off Appleby Lane at grid reference SE95660875 leading first south-westerly and then south along a worn track to the rear of properties on Appleby Lane, turning south-west again and crossing a spring, leading to its junction with public footpath 212 and Ermine Street at grid reference SE95600859.
