Definitive Map Modification (Public Footpath 74, East Halton) Order 2003(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 21st November 2003.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 74, East Halton) Order 2003(1).

SCHEDULE

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be deleted

A 256-metre-long footpath commencing at grid reference TA15702083 (Point A) and leading generally north-eastwards to grid reference TA15922097 (Point H), as indicated on the map.

Description of path to be added

A 508-metre-long footpath commencing at grid reference TA15702083 (Point A) and proceeds in a north-westerly direction for 98 metres to grid reference TA15652091 (Point B), then in a westerly direction for 40 metres to grid reference TA15612091 (Point C), then a north-westerly direction again for 42 metres to grid reference TA15592095 (Point D), then a north-easterly direction for 48 metres to grid reference TA15602098 (Point E), then a north-westerly direction for 30 metres to grid reference TA15582101 (Point F), and then in a north-easterly direction for 250 metres to grid reference TA15802114 (Point G). The footpath has a minimum width of 1.5 metres.

Limitations and conditions

A pedestrian gate erected and maintainable by the landowner in a security fence at (Point G) grid reference TA15802114, as indicated on the map.

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement
Variation of particulars of path

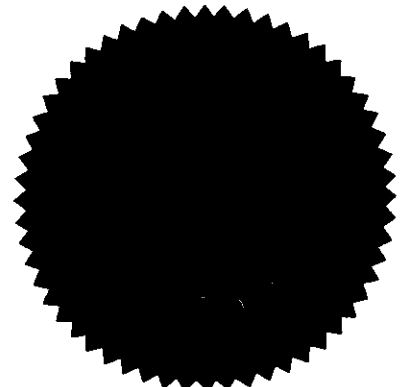
A 508-metre-long footpath commencing at Public Footpath 74 at grid reference TA15702083 and following the top of a planted bank in a first north-westerly direction for 98 metres to grid reference TA15652091, then in a westerly direction for 40 metres to grid reference TA15612091, then a north-westerly direction again for 42 metres to grid reference TA15592095, then a north-easterly direction for 48 metres to grid reference TA15602098, then a north-westerly direction for 30 metres to grid reference TA15582101, and then in a north-easterly direction for 250 metres to pass through a gate to its junction with Public Footpath 50 at grid reference TA15802114. The footpath has a minimum width of 1.5 metres.

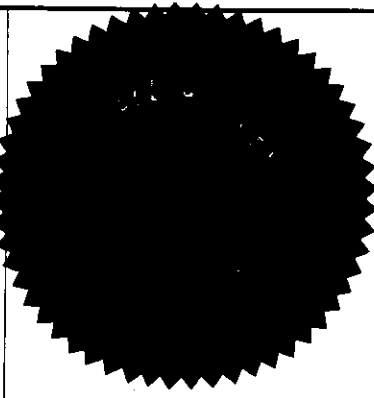
A4 Plotter Frame
