Definitive Map Modification (Public Footpath 78, East Halton) Order 2005(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

- 1. For the purposes of this order the relevant date is 3<sup>rd</sup> May 2005.
- 2. The County of Lincoln Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
- 3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 78, East Halton) Order 2005(1).

#### SCHEDULE

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be deleted

A-B as indicated on the map: A 228-metre-long footpath commencing midway along the existing footpath and the western boundary of O.S. Field number 8745 at grid reference TA1479619431, proceeding in a easterly direction to the south-eastern most point of O.S. Field number 9262 at grid reference TA1500019530.

## Description of path to be added

A - C as indicated on the map: A 279-metre-long footpath with a width of 2 metres commencing midway along the existing footpath and the western boundary of O.S. Field number 8745 at grid reference TA1479619431, proceeding along the western boundary of part of O.S. Field number 8745 and the whole of the western boundary of O.S. Field number 9262 and the eastern side of a drainage dyke in a northerly direction before crossing a 4 metre footbridge to join the existing footpath No.77 at the north-western corner of O.S. Field number 9262 at grid reference TA1474619695.

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement

Variation of particulars of path

A 279-metre-long footpath with a width of 2 metres commencing midway along the existing footpath and the western boundary of O.S. Field number 8745 at grid reference TA1479619431, proceeding along the western boundary of part of O.S. Field number 8745 and the whole of the western boundary of O.S. Field number 9262 and the eastern side of a drainage dyke in a northerly direction before crossing a 4 metre footbridge to join the existing footpath No.77 at the northwestern corner of O.S. Field number 9262 at grid reference TA1474619695.




