# Definitive Map Modification (Public Footpath 56 Epworth) Order 2005(1)

This order is made by North Lincolnshire Council under section 53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln - Parts of Lindsey (Isle of Axholme) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(iii) - namely, the coming into operation of any enactment or instrument, or any other event, whereby a new right of way has been created over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path - of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

- For the purposes of this order the relevant date is 11<sup>th</sup> November 2005.
- The County of Lincoln Parts of Lindsey (Isle of Axholme) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
- This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 56 Epworth) Order 2005(1).


