SCHEDULE

PART I

1. The Definitive Map Modification (Public Footpath Epworth 67) Order 2005(1) shall be made in accordance with the provisions of sections 100 to 103 of the Wildlife and Countryside Act 1981.

Definitive Map Modification (Public Footpath 67, Epworth) Order 2005(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Isle-of-Axholme) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 17th February 2005.
2. The County of Lincoln – Parts of Lindsey (Isle-of-Axholme) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 67, Epworth) Order 2005(1).

SCHEDULE

PART 1

Modification of Parts of Lindsey (Isle-of-Axholme) Definitive Map
Description of path to be deleted

A – C, as indicated on the map: A 73-metre-long footpath commencing from grid reference SE7748003815 and leading south to grid reference SE7747003748,

D – F, as indicated on the map: A 49-metre-long footpath commencing at SE7746403706 and leading south to grid reference SE7746403663.

Description of path to be added

B – C, as indicated on the map: A 72-metre-long footpath commencing at grid reference SE7748603813 and leading south to an area of public open space at grid reference SE7747003748.

D – E, as indicated on the map: A 49-metre-long footpath commencing south of an area of public open space at grid reference SE7746403706 leading east for 5 metres, south for 9 metres then changing to a westerly direction and curving south for 36 metres to grid reference SE7745603664.

The footpath has a minimum width of 1.5 metres within a constructed footway.

PART 2

Modification of Parts of Lindsey (Isle-of-Axholme) Definitive Statement
Variation of particulars of path

A 72-metre-long footpath with a minimum width of 1.5 metres within a constructed footway commencing at grid reference SE7748603813 and leading south to an area of public open space at grid reference SE7747003748.

A 49-metre-long footpath with a minimum width of 1.5 metres within a constructed footway commencing south of an area of public open space at grid reference SE7746403706 leading east for 5 metres, south for 9 metres then changing to a westerly direction and curving south for 36 metres to grid reference SE7745603664.
