Definitive Map Modification (Public Footpath 175, Flixborough) Order * 2002(2)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 27th September 2002.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 175, Flixborough) Order 2002(2).

SCHEDULE

PART 1

Modification of Definitive Map

Description of path to be deleted

A 400-metre-long footpath commencing at Point A and leading generally north-westwards in a line curving eastwards to Point B.

Description of path to be added

A footpath of a width of at least 3 metres commencing at Point A and leading for 400 metres generally north-westwards in a straight line to Point B.

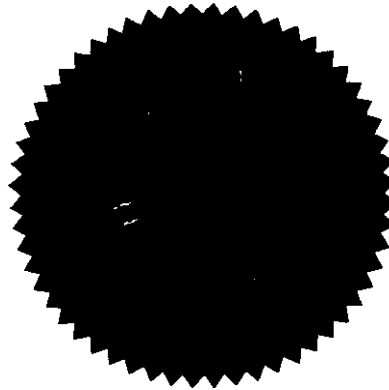
PART 2

Modification of Definitive Statement

Variation of particulars of path

A footpath of a width of at least 3 metres running for 400 metres in a north-westerly direction from an existing point on Public Footpath 175 at grid reference SE87731358 along the western side of a fence to another existing point on Public Footpath 175 at grid reference SE87601396.

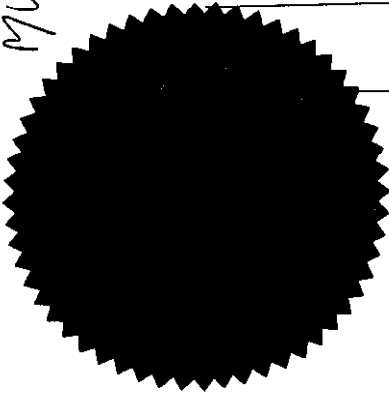
