Definitive Map Modification (Public Footpath 177, Flixborough) Order 2002(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map and statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 17th September 2002.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 177, Flixborough) Order 2002.

SCHEDULE

Modification of Definitive Map

Description of path to be deleted

A section of Public Footpath 177 shown on the map by a solid line and leading from the High Street at Point A (grid reference SE87351501) in a generally southerly direction for a distance of 57 metres to Point B (grid reference SE87351495) at the rear of Church Farm, then continuing in a generally south-easterly direction for a distance of 346 metres to Point C (grid reference SE87491464) on the southern side of the railway line.

A section of Public Footpath 177 shown on the map by a solid line leading from the southern side of the railway line at Point D (grid reference SE87631454) in a generally south-easterly direction for a distance of 222 metres to Point E (grid reference SE87751434).

Description of path to be added

A 213-metre-long footpath of a minimum width of 1.5 metres shown on the map by a broken dashed line and leading from the southern side of the railway line at Point G (grid reference SE87281473) in a generally south-easterly direction along the southern side of the railway line to Point C (grid reference SE87491464).

A 565-metre-long footpath of a minimum width of 1.5 metres shown on the map by a broken dashed line and leading from Point D (grid reference SE87631454) on the southern side of the railway line in a generally south-easterly direction along the western boundary of the land situate at Normanby Enterprise Park for 220 metres; then continuing in a generally south-westerly direction for a further 345 metres across open land to Point F (grid reference SE87621402).
