**DIVERSION OF PUBLIC FOOTPATH 74 HAXEY
PUBLIC PATH MODIFICATION ORDER 1999**

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the definitive map and statement for the County of Lincoln – Parts of Lindsey require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i), namely, a highway shown or required to be shown in the map and statement has been authorised to be diverted in accordance with the provisions of the Act.

The authority have consulted with every local authority whose area includes the land to which the order relates. The North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 13th. May 1999
2. The definitive map and statement for the County of Lincoln – Parts of Lindsey shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to this order.
3. This order shall take effect on the date it is confirmed and may be cited as the Diversion of Public Footpath 74 Haxey Public Path Modification Order 2000.

SCHEDULE

PART 1

**Modification of County of Lincoln – Parts of Lindsey Map
Description of Path or Way to be Deleted**

Public Footpath 74 in the parish of Haxey within the district and county of North Lincolnshire, having a length of 205 metres and running in a northerly direction from point A, between the eastern edge of Skyers Farm and the western edge of a dyke, to point B on the map.

Description of Path or Way to be Added

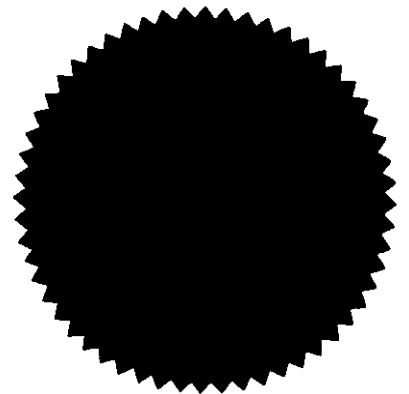
A footpath having a length of approximately 190 metres with a minimum width of 1.5 metres and running from point D in a north-easterly direction for 155 metres to point C, then east for 35 metres to point B on the map.

PART 2

**Modification of County of Lincoln – Parts of Lindsey Statement
Variation of Particulars of Path or Way**

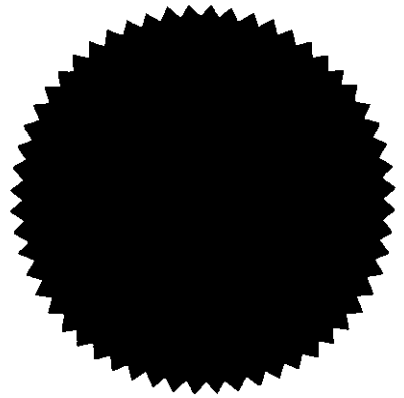
From Turbary Road at grid reference SE75840140, the path heads northwards over a footbridge 45 metres north-west of the entrance to Skyers Farm of a span of approximately 4.5 metres, then runs along the western edge of Skyers Farm for 155 metres to grid reference SE75890159. It then heads eastwards along the northern perimeter of Skyers Farm for 35 metres, to join a track at grid reference SE75920158. The section of public footpath described is 1.8 metres wide throughout.
