Definitive Map Modification (Public Footpath 212, Holme) Order 2005(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 3rd May 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 212, Holme) Order 2005(1).

SCHEDULE

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be deleted

A – B as indicated on the map: A 208-metre-long footpath commencing at the entrance to Raventhorpe Farm at grid reference SE9371808116 proceeding in a westerly direction for 30 metres, then in a southerly direction for 38 metres, then in a south-westerly direction for 140 metres to a point in the centre of O.S. field No. 60000 and the existing footpath at grid reference SE9358707962.

Description of path to be added

C – B as indicated on the map: A 132-metre-long footpath with a width of 1.25 metres commencing from a point 80 metres south of New Cottages Raventhorpe at grid reference SE93771507980, proceeding in a westerly direction over O.S. field No. 60000 to a point in the center of the same field and the existing footpath at grid reference SE9358707962.

PART 2

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement

Variation of particulars of path

A 132-metre-long footpath with a width of 1.25 metres commencing from a point 80 metres south of New Cottages Raventhorpe at grid reference SE93771507980, proceeding over a stile in a westerly direction over O.S. field No. 60000 to a point in the center of the same field and the existing footpath at grid reference SE9358707962.

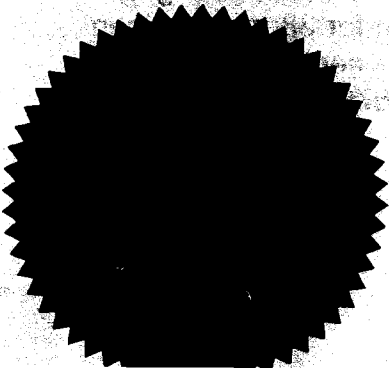

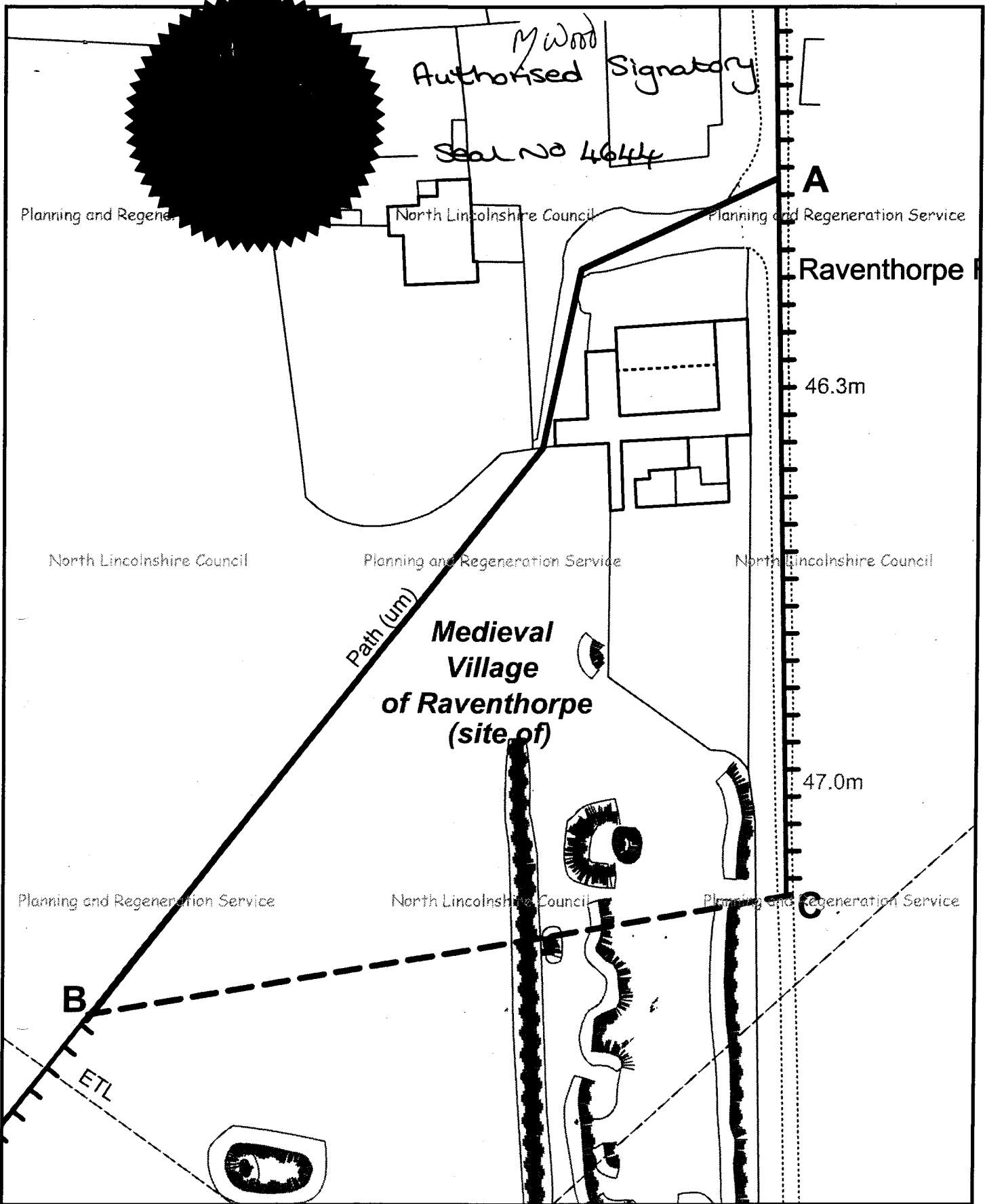
