### County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement

#### Definitive Map Modification (Public Footpath 248, Kirton-in-Lindsey) Order 2005(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 03 February 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 248, Kirton in Lindsey) Order 2005(1).

#### SCHEDULE

##### PART 1

##### Modification of Definitive Map

##### *Description of path to be deleted*

*A – B as indicated on the map:* From grid reference SK9364198990 and leading in a north-westerly direction through a northerly arc for 29 metres to grid reference SK9361599001, as indicated on the map.

*B – C as indicated on the map:* From grid reference SK9361599001 and leading in a northerly direction for 91 metres to grid reference SK9361399092, as indicated on the map.

*Description of path to be added*

*A – D as indicated on the map:* From grid reference SK9364198990 and leading generally north-easterly then northerly in an arc direction for 164 metres to grid reference SK9365399093, as indicated on the map.

*D – E as indicated on the map:* From grid reference SK9365399093 and leading in a westerly direction for 10 metres to grid reference SK9364299096, as indicated on the map.

*E – C as indicated on the map:* From grid reference SK9364299096 and leading in an arc direction generally south-easterly, then north-easterly for 36 metres to grid reference SK9361399092.

The footpath has a minimum width of 1.5 metres throughout passing in part through areas of public open space of a typical width of 5 metres.

PART 2

Modification of Definitive Statement

*Variation of particulars of path*

A 210-metre-long footpath with a minimum width of 1.5 metres passing in part through areas of public open space of a typical width of 5 metres from grid reference SK9364198990 and leading generally north-easterly, then curving northerly in an arc direction for 164 metres to grid reference SK9365399093, changing to a westerly direction for 10 metres to grid reference SK9364299096, and leading in an arc direction generally south-easterly, then north-easterly for 36 metres to grid reference SK9361399092.

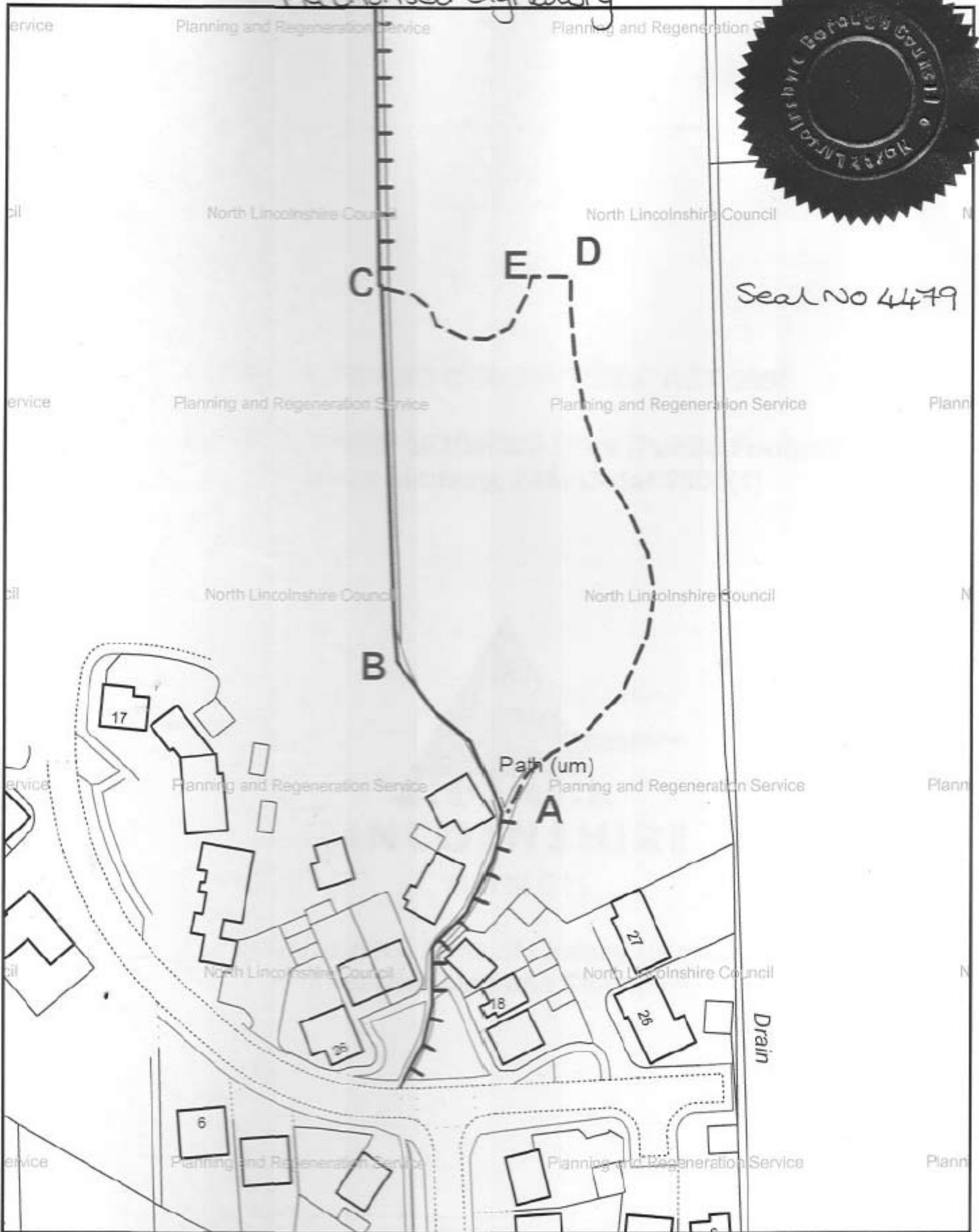
