Definitive Map Modification (Public Footpath 210, Messingham) Order 2005(1)

This order is made by North Lincolnshire Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) – namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map or statement has been authorised to be stopped up, diverted, widened or extended – of the Act.

The authority have consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 25 February 2005.
2. The County of Lincoln – Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 210, Messingham) Order 2005(1).

SCHEDULE

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map
Description of path to be deleted

A - B, as indicated on the map: A 54-metre-long footpath commencing at grid reference SE9200104189 that runs in a southerly direction from the Messingham Scawby Road to grid reference SE9199804133.

B - C, as indicated on the map: A 331.1-metre-long footpath commencing at grid reference SE9199804133 that runs diagonally across a field in a south-westerly direction to grid reference SE9229803894.

Description of path to be added

D - C, as indicated on the map: A 226.1-metre-long footpath with a width of four feet commencing on Brigg Road at grid reference SE9232904240 proceeding in a southerly direction from the Messingham Scawby Road to grid reference SE9229803894.


PART 2

Modification of Parts of Lindsey (Glanford Brigg) Definitive Statement
Variation of particulars of path

A 226.1-metre-long footpath with a width of four feet commencing on Brigg Road at grid reference SE9232904240 crossing a 3 metre footbridge and following the western boundary of a drainage ditch, proceeding across two small culverts and then following the western boundary of the same drainage ditch and the eastern boundary of a fence in a southerly direction to join the existing footpath at grid reference SE9229803894.

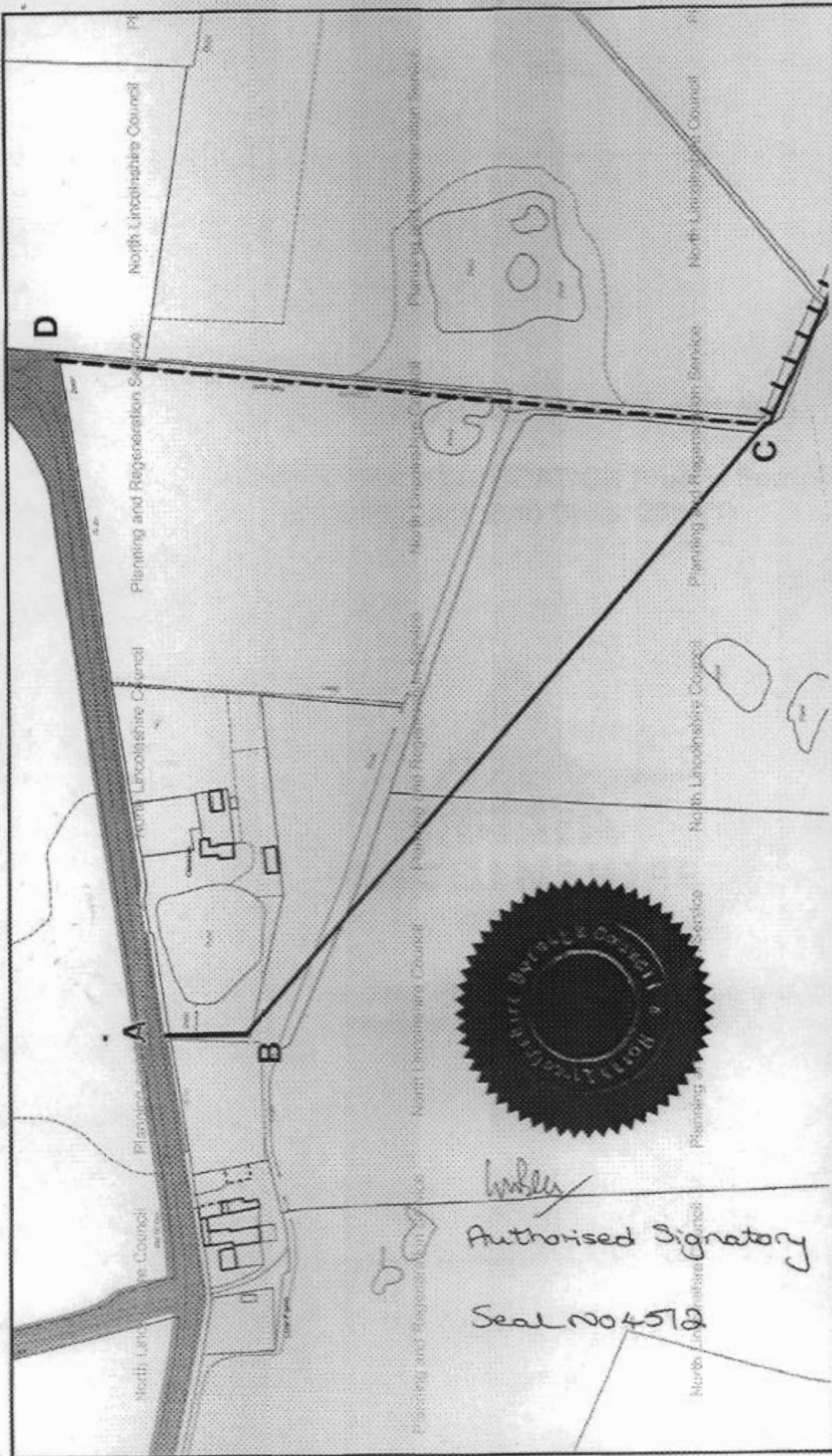
