**Definitive Map Modification (Public Footpath 263 Redbourne)
Order 2011(1)**

This order is made by North Lincolnshire Council under section 53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Lincoln - Parts of Lindsey (Glanford Brigg) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) - namely, the coming into operation of any enactment or instrument, or any other event, whereby a highway shown or required to be shown in the map and statement has been authorised to be stopped up, diverted, widened or extended .

The authority has consulted every local authority whose area includes the land to which the order relates. North Lincolnshire Council hereby order that:

1. For the purposes of this order the relevant date is 28th September 2011.
2. The County of Lincoln - Parts of Lindsey (Glanford Brigg) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the order.
3. This order shall take effect on the date it is made and may be cited as the Definitive Map Modification (Public Footpath 263 Redbourne) Order 2011(1).

PART 1

Modification of Parts of Lindsey (Glanford Brigg) Definitive Map

Description of path to be deleted

A – B as indicated on the map: A 134-metre-long footpath commencing at a point on the existing footpath at grid reference SK96989964, proceeding diagonally over a field in a north-easterly direction to a point on the western side of the B1206 at grid reference SK97089971.

Description of path to be added

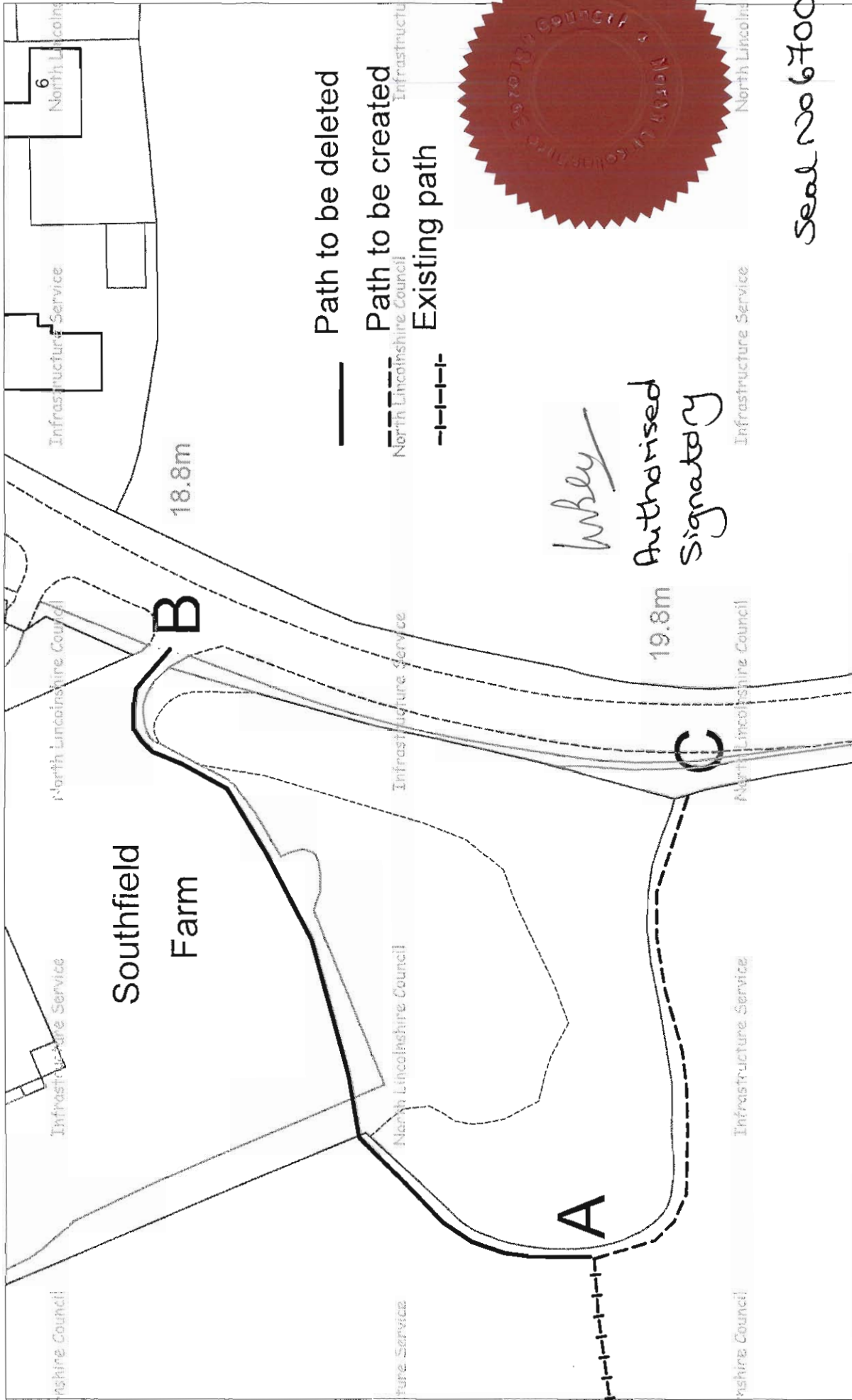
A – C as indicated on the map: An 83-metre-long footpath with a width of 4 feet commencing at a point on the existing footpath at grid reference SK96989964, proceeding along the northern boundary of a field edge and the southern side of a hedgerow in a first southerly, then easterly direction to a point on the western side of the B1206, at grid reference SK97069963.
